PROPOSAL

Demolish a ca. 1947 house.

ARCHITECTURE

One-story, rectangular-plan, stone-veneered frame house with a prominent stone-encased chimney on the front of the house; single and triple 1:1 windows; the original attached garage has been converted to a room with sliding glass doors facing the street.

RESEARCH

The house was built in 1947 by a local builder. The first owners and occupants were Reynolds P. and Faye Black, who lived here until around 1953. Reynolds Black was born on a farm in Hays County, Texas, and had lived in Brownwood, Texas prior to moving to Austin. He had been a book-keeper for a retail drug store in Brownwood and became the accountant and office manager for Renfro Drug Company in Austin. The Blacks later moved to Buda, and Reynolds Black worked as an accountant for a pipeline company.

The house was owned for a short period in the mid-1950s by a student, John Perkins. Around 1957, the house was purchased by Beulah Temple Wild, a former teacher from Ohio who had taught in Houston prior to moving to Austin. She was the director of social services at Brackenridge Hospital, and lived here until around 1980. The house was a rental property after that time.

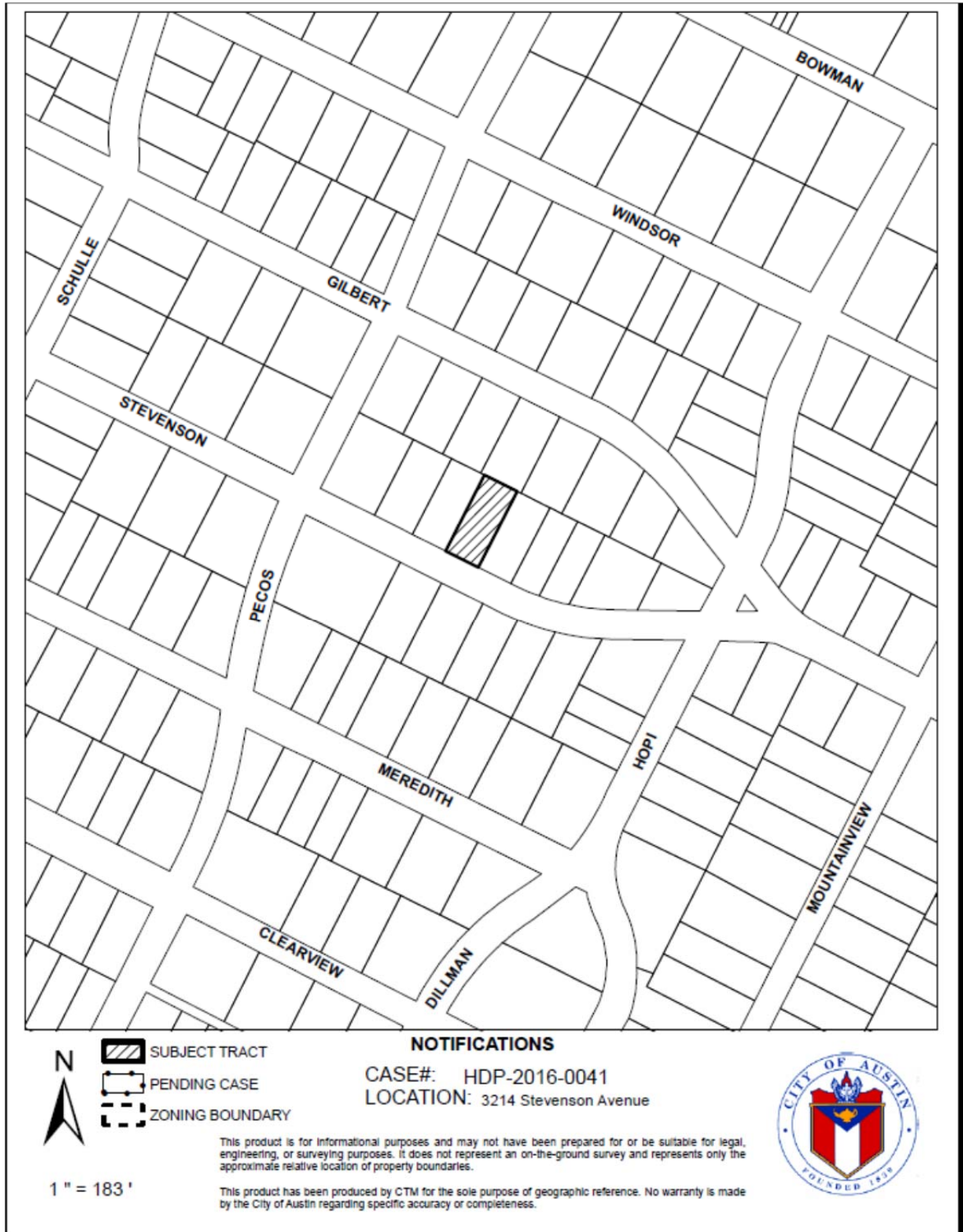
STAFF COMMENTS

The house is not listed in any City survey.

STAFF RECOMMENDATION

Release the permit upon completion of a City of Austin Documentation Package, consisting of photographs of all elevations, a dimensioned sketch plan, and a narrative history, for archiving at the Austin History Center. The house has neither the architectural nor the historical significance to warrant individual designation as a historic landmark, but represents typical late 1940s residential development in Tarrytown.

BIOGRAPHICAL NOTES

Reynolds P. and Fay Black (ca. 1947 – ca. 1953)

The 1940 U.S. Census shows Reynolds P. and Gladys V. Black as the owners of a house worth \$2,000 in Brownwood, Texas. Reynolds P. Black was 39, had been born in Georgia, and was the book-keeper for a retail drug store. Gladys V. Black was also 39, had been born in Texas, and had no occupation listed. They had no children listed with them.

The 1920 U.S. Census shows Reynolds P. Black as the 19-year old son of William and Ora E. Black of Hays County, Texas, where they rented their farm. Reynolds was the 2nd of the couple's 4 children listed in the census report. All the family save the two youngest children, had been born in Georgia. The two youngest children had been born in Texas. Reynolds Black is listed as a farm laborer on the home farm, as were his siblings. His father was a farmer.

According to his 1959 death certificate, Reynolds P. Black was an accountant for the Western Pipeline Company. He had been born in Georgia in 1900, and was living in Buda, Texas at the time of his death.

REYNODS P. BLACK

Reynods P. Black of Route 1, Buda, died in a local hospital Friday morning. He was employed as accountant for Renfro Drug Companies for a number of years and for the past three years was with the Western Pipeline Company. He was a member of the Manchaca Methodist Church. Survivors are his widow, Mrs. Fay Black; one sister, Mrs. N. E. Holland of Robstown; and two brothers, Vernon Black of Donna, and Henry Black of McAllen.

Funeral services will be held at 2:30 p.m. Saturday at the Cook Funeral Home with the Rev. Charles Neal officiating. Active pallbearers will be Oscar Stease, C. G. Conner, Noel Burton, A. P. Simpson, Dr. Elwood Brewer, and Glenn Pope. Honorary pallbearers will be Fred Carpenter, Allan Shivers, Gary Morrison, Joe Renfro, Clem Fain, H. E. Jacobsen, R. C. Ammann, George H. Marsh, Charles Ferguson, Leonard A. Smith, and the Board of Stewards of the Manchaca Methodist Church.

Beulah M. Temple Wild (ca. 1957 – ca. 1980)

Beulah M. Wild appears in the 1920 and 1923 city directory for Baltimore, Maryland. She was a teacher who lived at 512 E. 28th Street in Baltimore. In 1923, at 514 E. 28th Street (next door) lived Frederick W. and Bertha M. Wild; Frederick W. Wild was a teacher. He does not appear in the 1920 city directory for Baltimore. The 1929 Houston city directory shows Beulah T. Wild as a visiting teacher in the Houston Public Schools. She lived at the Plaza Apartment Hotel. The 1932 Houston city directory shows her as a teacher at the Hamilton School in Houston. The 1937 Houston city directory shows Beulah T. Wild as a social worker for the Houston Child Guidance Clinic.

The 1930 U.S. Census shows Beulah T. Wild as the renter of an apartment in Houston, Texas. She was a 31-year old divorcee who had been born in Ohio and was a public school teacher. She lived alone.

The 1920 U.S. Census shows Beulah M. Wild as the renter of a house in Middle Point Village, Van Wert County, Ohio. She was 21, had been born in Ohio, and was a public school teacher. With her lived her sister, Eunah V. Temple, 27, who had also been born in Ohio, and was also a public school teacher.

According to her 1980 death certificate, Beulah Temple Wild was born in Ohio in 1898. She was living at this house at the time of her death. She was a retired social worker who had been divorced.

A detached greenhouse was approved in 2002. A new in-ground pool and spa was approved in 2010, and again in 2012.
