

FIRST RENEWAL AND AMENDMENT OF
INTERLOCAL AGREEMENT BETWEEN THE CITY OF AUSTIN
AND THE UNIVERSITY OF TEXAS AT AUSTIN FOR RESTORE RUNDBERG

This First Renewal and Amendment (“Renewal”) of this interlocal agreement (“agreement”) is entered into by the following parties: the City of Austin, a Texas home-rule municipal corporation and political subdivision of the State of Texas ("City") and the University of Texas at Austin (the “University”), hereinafter collectively referred to as a “Party” or “Parties”, pursuant to the Interlocal Cooperation Act, Texas Government Code Chapter 791.

WHEREAS, the City received a grant from the U.S. Department of Justice, Bureau of Justice Assistance, to implement a Byrne Criminal Justice Innovation program in the Rundberg Neighborhood, referred to as “Restore Rundberg”;

WHEREAS, the Parties acknowledge that the U.S. Department of Justice allows the City to serve as Fiscal Agent for Restore Rundberg;

WHEREAS, the grant requires a partnership between the City and a research partner for the duration of the grant period to complete research and evaluation components;

WHEREAS, the approved grant scope of work and budget include funding to secure the services of the University for the duration of the grant period;

WHEREAS, the City and the University desire to complete the research and evaluation components as outlined in both the City’s approved grant proposal and an implementation plan;

WHEREAS, the initial term of the agreement was from November 27, 2012 through November 26, 2015;

WHEREAS, the City received a 10 month grant period extension with a new end date of September 30, 2016;

WHEREAS, The Parties now desire to approve an extension of the agreement to September 30, 2016, and to approve continuation of the Parties’ rights and obligations under the agreement;

NOW, THEREFORE, in consideration of the hereinafter set forth agreements, covenants, and payments, the amount and sufficiency of which are acknowledged, the University and the City agree to the changes in terms and conditions stated in this Renewal.

1.0 AGREEMENT TERM

1.01 **Renewal Term.** The Parties agree to renew the agreement for an additional term beginning November 27, 2015, and continuing through September 30, 2016 ("Renewal Term"), unless earlier amended or terminated by the Parties pursuant to the agreement Terms.

1.03 **Effective Date.** The Parties agree that the effective date of this Renewal is November 27, 2015, upon execution of this Renewal by both Parties.

2.0 TERMS

2.01 **Agreement Terms.** The Parties agree that all terms of the agreement remain in full force and effect for the Renewal Term, subject to written amendment of the agreement.

3.0 INCORPORATION

3.01 University and City hereby incorporate the agreement into this Renewal. Except for the changes made in this Renewal, University and City hereby ratify all the terms and conditions of the agreement. The agreement, with the changes made in this Renewal, constitutes the entire agreement between the Parties and supersedes any prior undertaking or written or oral agreements or representations between the Parties with respect to the subject matter hereof.
