**IMPARTIAL HEARING EXAMINER'S MEMORANDUM NO. 10:
SETTING PROCEDURAL SCHEDULE**

At the prehearing conference convened on Friday, March 4, 2016 at Town Lake Center, Assembly Room, Room 130, located at 721 Barton Springs Road, Austin, Texas, the parties discussed the proposed procedural schedule that Austin Energy presented to the City of Austin City Council on March 3, 2016. The parties and the Impartial Hearing Examiner agreed to most of the dates Austin Energy proposed; the one exception is with regard to the date the Impartial Hearing Examiner's final report to the City Council is due. Austin Energy proposed the date of July 14, 2016; the Impartial Hearing Examiner suggested July 15, 2016 and the parties, including Austin Energy agreed to this change.

Therefore, pursuant to agreement of the parties, the Impartial Hearing Examiner adopts the schedule set forth in Attachment A to this Memorandum No. 10.
