**RULING ON INDEPENDENT CONSUMER
ADVOCATE'S ADDITIONAL ISSUES**

The Impartial Hearing Examiner is in receipt of the Independent Consumer Advocate's ("ICA") proposed issues to add to the Statement of Issues identified in the Impartial Hearing Examiner's Memorandum No. 11. Pursuant to Rule § 8.1(a), the Impartial Hearing Examiner hereby **GRANTS** the ICA's request to add the issues noted below to the Statement of Issues:

1. Should Austin Energy's proposal to change the rates that are applicable to Houses of Worship (HOW) be retained, rejected, or modified?
2. Should any changes be made to Austin Energy's three Residential Service Pilot Programs: Time-Of-Use Rates (Appendix K, pp. K-43 to K-44), Prepayment Rates (Appendix K, p. K-44 to K-46), and Plug-In Electric Vehicle Charging Rates (Appendix K, pp. K-46 to K-47)?

The ICA's additional issues are hereby incorporated into the Statement of Issues listed in Memorandum No. 11.
