## HISTORIC LANDMARK COMMISSION MARCH 28, 2016 DEMOLITION AND RELOCATION PERMITS HDP-2016-0082 - A 407 W. 39<sup>th</sup> Street

#### **PROPOSAL**

Demolish a ca. 1913 house.

#### ARCHITECTURE

One-story, rectangular-plan, front-gabled Cumberland-style frame house with a full-width, shed-roofed independent porch on plain, square wood posts and brick piers; single and paired multi-light fenestration; non-historic porch railing.

#### RESEARCH

The house appears to have been built around 1913. The first occupant was Hal C. Weaver and his wife, Susie, who lived here until around 1915. A native of Michigan, Hal C. Weaver was an instructor in electrical engineering, and also in mechanical engineering at the University of Texas. From 1915 to around 1917, the house was occupied by Gus K. Eifler, who with James M. Faulk, operated by the Hyde Park Drug Store at 40<sup>th</sup> and Guadalupe Streets. For a year or so on either side of 1920, the house was rented by Eric V. and Ellen Berkman. Eric V. Berkman was a grocery clerk who later became the manager of a retail grocery store.

Carl and Maxie Lewis were the longest-term occupants of this house. They lived here from 1933 to around 1943. Carl Lewis was a book-keeper, who worked for the J.R. Reed Music Company on Congress Avenue.

From around 1943 to around 1950, the house was rented by Gerald E. and Karleen Williams. Gerald E. Williams was a native of Oklahoma, but grew up in the Rio Grande Valley, and was a public school principal in Sweetwater, Texas for a time. He became active in the Boy Scouts of America, and is listed as the assistant scout executive in the 1944-45 city directory, the first that indicates his residency in this house. Williams was also very active in the Baptist Church, and served as the student director for the University Baptist church and education director for the First Baptist Church.

The house has been a rental property for many years. More recent tenants included a clerk for the State Department of Public Welfare, and a salesman.

#### STAFF COMMENTS

The house is neither within the boundaries of the Hyde Park National Register Historic District nor the Hyde Park Local Historic District. The house is listed in the Comprehensive Cultural Resources Survey (1984) but with no priority for research.

#### STAFF RECOMMENDATION

Encourage rehabilitation and adaptive re-use of this house if possible, then strongly encourage relocation over demolition. The house is a good example of a 1910s vernacular Cumberland style house that appears to be relatively intact, if a little shabby, and should be preserved and rehabilitated, even if on a new site. Staff does not believe that the house has the requisite historical and architectural significance for landmark designation, and therefore, with the above request to seriously consider relocation over demolition, recommends release of the permit upon completion of a City of Austin Documentation

Package, consisting of photographs of all elevations, a dimensioned sketch plan, and a narrative history, for archiving at the Austin History Center.

Hal C. and Susie Weaver appear in the 1920 U.S. Census as the owners of the house at 2318 Trinity Street in Austin. Hal C. Weaver was 36, had been born in Michigan, and was a stationary engineer. Susie Weaver was 32, had been born in Texas, and had no occupation listed. They had 2 daughters: Helen, 5; and Margaret, 3.

#### Eric V. and Ellen Berkman (ca. 1919 – ca. 1921)

The 1920 U.S. Census shows E.V. and Ellen Berkman as the renters of this house. E.V. Berkman was 29, had been born in Texas to Swedish-born parents, and was a clerk in a grocery. Ellen Berkman was 31, had been born in Texas to Swedish-born parents and had no occupation listed. They had no children listed with them. By 1930, according to the census report of that year, the Berkmans had moved to 4101 Avenue C, a house they owned, and which was worth \$4,000. Eric Berkman was the manager of a retail grocery store. They had no children.

#### William W. and Kibbie Brown (ca. 1929 – ca. 1932)

The 1930 U.S. Census shows William W. and Kibbie Brown as the renters of this house. William W. Brown was 42, had been born in Tennessee, and was a traveling salesman for road machinery. Kibbie Brown was 42, had been born in Texas, and had no occupation listed. They had 2 children: Clovis A. Brown, 15; and Mary B. Brown, 8. Both children had been born in Texas.

#### Carl H. and Maxie Lewis (ca. 1933 – ca. 1943)

The 1940 U.S. Census shows Carl H. and Ida Maxie Lewis as the renters of this house. Carl H. Lewis was 47, had been born in Texas, and was the book-keeper for a retail home appliance store. Ida Maxie Lewis was 44, had been born in Tennessee, and had no occupation listed. They had 3 children: Doris J., 23, a operator for the telephone company; Arthur D., 21, a private tutor; and L. Maxie Louise, 19. All the children had been born in Texas.

The 1930 U.S. Census shows Carl H. and Maxie Lewis renting the house at 1714 Lavaca Street. Carl H. Brown was a 36-year old book-keeper for a music store. Maxie was 32 and had no occupation listed. They had 3 children: Doris J.., 13; Arthur D., 11; and Louise, 9. They had 5 lodgers in their home: Ruby Greer, 20, a Texas-born clerk in the Land Office; Louis Aderholt, 24, a Texas-born automobile salesman; Louis Machu, 24, a Texas-born auto mechanic; Billie Tittsworth, 18, a Texas-born waiter in a boarding house; and Chilton Greer, 28, a Texas-born clerk in the State Comptroller's Office.
