

## M/WBE Summary

Public notice was given for this solicitation, CLMC567 FM973 Wastewater Line Improvements, through the City's Vendor Connection web portal which resulted in 491 contractors receiving notification. Nine contractors obtained the bid documents and nine bids were received and opened on January 7, 2016. Three out of nine bids received were certified MBE/WBE firms. Santa Clara Construction, LTD submitted the lowest responsive bid of nine bids received:
