

## M/WBE Summary

Public notice was given for this solicitation, CLMC538B, through the City's Vendor Connection web portal which resulted in 263 contractors receiving notification. Six contractors obtained the bid documents and three bids were received and opened on January 21, 2016. Two out of three bids received were certified MBE/WBE firms. Santa Clara Construction, LTD submitted the lowest of 3 bids received:
