

M/WBE Summary

Public notice was given for this solicitation, CLMC568 NW Brentwood Karen & Payne Area Neighborhood Water System Upgrades project, through the City's Vendor Connection web portal which resulted in 667 contractors receiving notification. 11 contractors obtained the bid documents and six bids were received and opened on January 7, 2016. Four out of six bids received were certified MBE /WBE firms. Santa Clara Construction submitted the lowest responsive bid of six bids received:
