Authorize award and execution of a 36-month contract with TEXAS ENTERPRISES DBA ALLIED SALES CO., to provide industrial lubricants in an amount not to exceed \$1,145,350, with three 12-month extension options in an amount not to exceed \$381,783 per extension option, for a total contract amount not to exceed \$2,290,700.

Amount and Source of Funding

Funding in the amount of \$190,892 is available in the Fiscal Year 2015 – 2016 Operating Budget of Austin Water. Funding for the remaining 30 months of the original contract period and extension options are contingent upon available funding in future budgets.

There is no unanticipated fiscal impact. A fiscal note is not required.

Additional Backup Information			

The contract will provide industrial lubricants for equipment at various Water and Wastewater Treatment Plants. The industrial equipment at the plants has been in place for over 35 years, and requires lubrication for daily operations and to prevent malfunctions.

This recommendation is in accordance with Local Government Code 271.905 and Resolution number 20140807-113 to invoke local preference. This local bidder is offering the best combination of contract price and additional economic development opportunities for the City created by the contract award, including the employment of residents of the City and increased tax revenues to the City.

Austin Water plant operations are vital as any down time may be detrimental to Austin residents' drinking water.
