I am going to convene the city council meeting on Thursday, September 10, 2015. We are in the Austin city council chambers. It is 10:10. 301 west second street. We're going to convene this meeting. We have changes and corrections.

Note that at 10:00 we're going to handle the zoning cases, restrictive covenants. We're going to have citizens communication at noon. We will convene an Austin finance corporation board meeting and then public hearings. The items to be pulled off of consent agenda, and I can't read my print here, it's items 8 and 9 are going to be heard with 15. And also on the nominations and waivers, I'm going to pull from this list bill Espey in the flood mitigation task force. I have a question I need answered about that first so we're not going to proceed on that nomination this morning. So with those changes, we have -- you want to present for us, Greg, the consent, which I think the consent agenda is everything on the agenda. Is that correct?

>> Yes. So good morning, mayor and council, Greg Guernsey with the planning and zoning department. I'm go through the consent. Item number 15, this approved second and third reading for the property at 1901 turnersville road or pud district zoning. This is related to items number 8 and number 9 in your agenda and I'll come back and read those two at the end because those can also be offered for consent.

Item 17, case C 14-0194 for the property on -- to loan to mixed use conditional overlay combined district zoning and this is ready for consent approval on second and third reading. Item number 18, C 14-2015, 54 for the property located at 90 -- east sixth street. Approve second and third reading. Transit oriented district. Conditional overlay and neighborhood plan. Combined district zoning and this is also ready for approval on second and third readings. Item number 19, for the property located at 500 shady lane in the govalle neighborhood combined planning area. We have a request for postponement by the neighborhood to your October [inaudible] Agenda. Related zoning item 20. For the property at 500 shady lane. Neighborhood has requested postponement of this item to your October 8th agenda. Item number 21, case npa 20150017.01. This is property located at 2000 Justin lane.

The zoning change request to limited industrial services, planned development use, limited plan and P combining district zoning. The planning commission did recommend the li-pda combined zoning and this is ready for consent approval on first reading only. That's in item number 35.

Consent approval on first reading only. Item income 36, this is case c-14-2015-0080 for the property at 11,200 north F.M. 620 road. This would have been the discussion item. Staff is requesting a suggested postponement to next week on your agenda, September 17th. Item number item number 37 is c-14-2015-0081 for the property located at 2513 east 10th street. This is to zone the property to neighborhood office mixed use neighborhood plan or no-mu combined district zoning. Planning

commission recommendation was to grant neighborhood office mixed use conditional overlay neighborhood plan or no-mu-co-np combined district zoning and this is ready for consent approval on all three readings. Item number 38, this is case c-14-2015-0091 for the property located at 1900 Burton drive and 1901 mariposa drive. Staff is requesting a postponement of this case to your November 2nd agenda. It's not yet been considered by the commission and won't be considered until the month of October. Item number 39 is case c-14-2015-0096 for the property located at 10035 manchaca road. This is to zone the property to general commercial services or cs district zoning. The planning commission's recommendation was to grant the cs-co combined district zoning and this is ready for consent approval on all three readings. Item number 40 is case c-14-h-2015-006 for the property located at 614 blanco street and the castle hill historic district. I understand that the adjacent property owners have requested a postponement of this item. The applicant has agreed to a postponement for one week to your September 17th agenda.

And that concludes the zoning items I can offer for consent. Oh, under the items 8 and 9 under planning and zoning these two are related to item 15 which I was offering for consent. Item 8 is to approve second and third reading adopting the first and amended restated strategic partnership agreement between the city and sinfield municipal utility district number two. We can offer that item as consent for second and third reading and also item number nine, approve an ordinance for second and third reading to an amendment for an agreement concerning the operation and agreement of the winnfield municipal utility district one, two, three and four. Winnfield now named sunfield, concerning the requirements and restrictions of the water districts. So I would also offer number nine as consent approval for second and third reading as well.

- >> Mayor Adler: In addition to that on the consent agenda is the minutes number 1, the 154,000-dollar settlement recommended by staff, judgment rather, the judgment, I guess required by the court and recommended by staff. And then the execution of the one-year service agreement number three, the one-year contract number four and five, six and seven as well. Those are also on the consent agenda. We have some speakers to speak to the extent agenda. I'm going to call them up real fast. Mr. Pena, are you here?

- >> Renteria: Mayor, I also want to pull 15 and 16 just for a question.
- >> Pool: Mayor, could you read real quick the items that will not be on consent?
- >> Mayor Adler: Everything is on -- the only thing that's not on consent is the item that is withdrawn. Some things are on consent for postponement.

I went into the city clerk's office and asked, since I was asked what did I need, we have a rude employee over there and you need to take care of her actions, inappropriate actions. Mayor, I just wanted to know where is the complete agenda at? It doesn't list the zoning, it doesn't list anything else other than things that we should know about.
- >> Mayor Adler: I think probably, Mr. Pena, it was confusing today because we have --
- >> I am confused too as a taxpayer.

- >> Mayor Adler: We have two concurrent meetings goings on so there are two agendas.
- >> Sir, where is the second agenda? There's only one agenda out there and it just lists partial listings. I apologize for taking some of the time, but this should be complete and it's not out there.
- >> Mayor Adler: There's an agenda that's posted under Austin city council regular meeting at 10:00. But then there's also the agenda that's posted for the budget meeting.
- >> I understand that, but the other one is not out there. It's just the one with the certain issues that are dealing with the budget, et cetera. It doesn't list the zoning cases. That's why the public is confused and that's why I get angry because I have to go over there and deal with a rude employer.
- >> Mayor Adler: I just pulled it up on my computer so there's a link for Thursday's regular session meeting.
- >> Okay.
- >> Mayor Adler: And it lists all of the cases -- no. There's that one toolbox the one you found.
- >> Where is the other one found?
- >> Mayor Adler: I just pulled it up.
- >> The paper. No, sir, it's just this right here. Just here, nothing else, sir.
- >> Mayor Adler: Got you. Would you please hand him a copy. Thank you for pointing that out.
- >> This would not have happened, sir --
- >> [Inaudible].
- >> I'm not here to discuss it with you, I'm here to discuss it with the mayor. Mayor, could you do me a favor?

What item are we on now?

- >> Mayor Adler: What is -- what we're discussing right now is the zoning cases that Mr. Guernsey just went through and in addition to that the seven items that are, that one is a judgment --
- >> Excuse me. Specifically the item that I'm here to speak of, I don't have that with me.
- >> Mayor Adler: What item would you like to speak on?
- >> I want to speak budget, I want to speak on the issues related to the budget.
- >> Mayor Adler: I'm going to let you speak to the budget.
- >> Okay. All I want to know is this. And I'm no dummy. I ran for justice of the peace endorsed by Apa, sheriffs, et cetera. Please, I would like to be treated with respect, number one. Number two, I want to let people this know that there are certain issues dealing with budget that are not being taken care of and we talked about social service issues fully funded, homelessness. I spoke with the secretary of hud yesterday, Mr. Castro, a friend of mine, and he was concerned about the meeting we were supposed to have regarding helping the homeless veterans transition into housing and that is a key critical issue as it is with the secretary and also president Obama. I spoke with his chief of staff this morning and I told him what happened here in Austin. We get conflicting information and this is a good article from the american-statesman. And Patrick, -- and we want to make sure that social service funding is complete. We have people on the street that shouldn't be out there. We shouldn't talk double speak. I'm losing lives and veterans out there. You know how many veterans are in our organization it's many as they're growing and they're Po'd on what's not occurring for them, both male and female. Mayor, I'm very concerned about how the city of Austin and the direction the city of Austin is going to.

Anyway, I'll leave it at this. We have people against hiring additional officers. We have seven cartel out there. They want to cap me out there, they could cap me. I have friends out there in the feds, et cetera.

We have the gangs increasing. And they're following people like no tomorrow, the ones that are talking about them. So I would suggest respectfully we hire as many officers as we can, the status quo. We need public safety just like we need social service funding for the people to survive. Also, children, you talked about jobs for -- summer job programs for students. We've been speaking since mayor Todd was mayor. We need that for us. We need it fully funded. When the health care is fractured here in austin-travis county. And if you want to, we can have a meeting about that also and I suggest, strongly suggest that you have that meeting also for the veterans also. But anyway, I'll leave it at that. I know I rambled a little bit. But mayor, I used to work for the city of Austin, parks and recreation department and the municipal court as bailiff. I treat people with respect and I expect to be treated with respect. When somebody says can I help you and says wait a minute, hold on a second, that's inappropriate verbiage, Mr. City manager. I've called on the carpet a lot of people who have been disrespectful. A lot of people know mow throughout the united States, but mayor, this city needs help. We need help out there and it ain't getting to the people. We need to have the arch moved, we need better service for the people of the arch and the salvation Army and also Ann Howard needs to be more honest about how many homeless veterans there are. It's not 252. It could be up to 5,000, 500 at any given time. Thank you very much, Mr. Mayor. Clean it up, please.

>> Mayor Adler: The next speaker we have is Jesse brown.

We have speakers on -- Larry Oleta? Larry Oleta. Marks, as you're calling this up, that item was taken on the planning commission agenda this past Tuesday and I have an email from the owner's representative saying that she's okay going to first reading, but really wants to keep the public hearing open because they're still meeting with the neighbors. So we have two speakers identified on this item number 29.

- >> Houston: Excuse me, mayor. I thought that was a valid petition. Is that not true?
- >> The applicant is okay with going on first reading today if the public hearing can be kept open when it comes back for second and third reading.
- >> Thank you.
- >> Mayor Adler: We will add to the consent agenda that the public hearing will be left open on item number 29. We have two people that are here to speak on 29, recognizing that this item is only going to get approved on first reading on consent and that the public hearing will still be left open, which is when this council is going to be really hearing arguments and considering this matter depending on how the group -- how the neighborhood and the applicant, what they can work out or the work they're doing.

I'm going to call those speakers and see if they want to speak now with the public hearing still open. Two speakers, Marco Montoya. Do you want to speak now or wait until the public hearing is open later? >> I will speak now.

>> Morning, Mr. Mayor, members of the council. My name is Marco Montoya, a resident of Austin. I live on pecan springs road, a street and property impacted by the proposed request for rezoning. I'll keep it short. I realize it's budget discussions and I'll say that three important reasons why I think the public discussion should continue. One, the role of the neighborhood planning function and zoning decision process has become very confused. So I'm very concerned about how that has impacted the process. Secondly the role of the planning commission in developing recommendations to your body is definitely very unclear in my opinion regarding the impact of its decisions, not just on the zoned definition, but on the housing situation and conditions of the city. For example, safety of workers employed in the construction industries occupy 20% of the money spent in the emergency room and I think that's an

important number. It's a large number. The third factor, though, is that my opposition stems from the fact at this time that is not sufficient community input regarding the five property units that are proposed on pecan springs road.

And it is affected with a two-story approach as compared to one-story. Safety, the nature of construction, the lack of coordinated effort. A good example is fact that we have proposed a building of 38 homes, units, across the street or 20 additional ones across the other street are 60, I believe. The impact of that is significant on the current neighborhood of 14 homes. So there's a significant aspect to this beyond just public discussion. Thank you.

- >> Mayor Adler: Thank you, sir.
- >> Questions?
- >> Mayor Adler: We have one other speaker that's identified on this, recognizing that if this passes today on first reading we are keeping the hearing open so the public hearing can happen. But does Chris ring want to speak today as opposed to waiting for the public hearing?
- >> Yeah, I'll speak just real quickly. I wasn't aware that we would be formally invited to speak in the future, but since I'm here I'll make it real quick. I signed this as in between, kind of undecided here and I understand it needs to be developed, but like Marco pointed out we have an existing neighborhood. It's not raw land. It's an established neighborhood. We're talking about replacing three houses. Each one is on acreage with 38 homes, 38 units. Condominium units, each one the owner would only own the building, not the land it's on. And what I see -- just the big picture to me is that we are in an established neighborhood with the 38 units that tend to be transient in nature.

These are people who it's more like a stepping stone than a destination community like it is now. The neighborhood is a place where people go and generations grow up. As I was thinking this morning, there are people driving by my house, look at it and go, I grew up there 20, 30 years ago and what it's going to be replaced with is something entirely different. These are going to be people that are on their way to -- they're buying quite expensive homes actually. They won't be affordable. And they will only be able to afford the house without the land, just a building. And I guess I'll end there. I know you're busy. Thank you.

- >> Houston: Mayor, I'd like to thank the two neighbors for coming down this morning. This is a first time for them and so I appreciate you doing that and we look forward to seeing you back again.

Does chip Harris speak today? This is item number 21. Does owe on owe does Nancy Harris need to speak today? Thank you. Thank you for giving us the time.

- >> Pool: Mayor, a question. Items 21 and 22 are the same property. Mr. Guernsey, are they both being postponed to the same day?
- >> Mayor Adler: Yes, to October 1st.
- >> Pool: Okay, thanks.
- >> Mayor Adler: Okay. Thank you.

I don't know what councilmember Zimmerman's cases are, but if we could not have those next week?

- >> Mayor Adler: I have three set on sentth, 23, 24, seven.
- >> Sorry, 23 and 24 are the same case. 27 I thought is that -- is 27 also?
- >> Mayor Adler: And also 36 and 40.

>> Gallo: Whoa, whoa. I had my hand up. Once again I'm going to vote against granting this waiver for construction of a residential property in addition to the 100 year floodplain. We have asked staff to come forward to us with a policy for this type of situation. The waiver would be granted. The proposed finished floor is below the minimum required elevation. Staff has indicated that there is no safe access for our public safety in the case of a flooding episode and there doesn't appear to be any hardship to the occupant because there is an existing home there already. This would be in addition to that. So I just think as we deal with recent flooding and recent floodings within the last several years that allowing people to continue to build in the floodplain areas and then the city facing situations where the taxpayers are spending a lot of money to then go into buyouts for these areas to make sure that occupants and residents are safe, I just think that this is a policy that we need to have a larger discussion on and continuing to allow people to get waivers to build in the floodplains is not an appropriate policy decision for the council at this point.

- >> Mayor Adler: Ms. Pool and then Mr. Zimmerman.
- >> Pool: I also oppose allowing this to be built in the floodplain. I did agree to move this, to move it forward last time, but that was simply to move it forward. On a policy basis I do not support.

>> Mayor Adler: And your vote in order to move it forward last week was appreciated and I had asked for that. Mr. Zimmerman?

>> Zimmerman: Thank you, Mr. Mayor. I have spent a number of hours studying this particular case. We discovered that the increase in the flood level based on the flood level in the 1970s was due to mathematical modeling, so there was a new mathematical model that attempted to bring in mu data. I brought in some study on that. I don't see how clinically the mathematical model can be really proven. It's an estimate of the increase, potential increase of the level. As somebody that does math and complex engineering models, I can't justify the model, but be that as it may, even if the model is correct, what happens if the water comes up eight feet over the spillway, which is hard to conceive, but even if it did, the estimated speed of the water would be around zero feet per second. In other words, the water is not moving. And councilmember Gallo raises a great point on the policy, but I can have a very common sense policy statement here we should explore more, but if you are behind a dam, if you're behind a dam, you're not on a river because you're behind a dam. And when you look at these water levels that rise towards the edges where the homes are, your water velocity is around zero. It's not running. It's standing water. That makes a huge difference on the safety aspect of being able to just simply walk out of your home in the case of an emergency. So I think this is very different than your onion creek situation where we see those horrible videos of the water, dangerous water going down the street.

>> Mayor Adler: Just real quickly in terms of this case, I agree with Ms. Gallo that we really need to have a policy that we can adopt uniformly and I'm happy that we're working that way. In fact, it allows him to build what will become the safest part of this entire building. As we've said before if there was a flood situation, depending on how slowly the flood rises, if the person couldn't get out of the house, if you can get as quickly to the room that is just about to be able to build if this gets approved. So if there was ever a situation where we would grant an exception to the general, this is I think the one for me. I said that by way of reminding what the case was. Any further discussion on this? Those in favor of granting this variance please raise your hand? Zimmerman, troxclair, Renteria, Casar. It is a six-five vote. Third reading it passes. I think that is everything on our agenda.

New York City was concerned about where its water was coming from because it's a state where fracking so they commissioned a study. What they found was Frack, 570 types of chemical used in every frac. University of Missouri medical school found that there's 700

[inaudible] Per frac a lot of which will total organic compounds which get into the air.

[Inaudible] I talked about they banned it because of the health impacts. The people that were living anywhere close to the frac. California has found these chemicals in eight of aquifers. I'm not sure that Texas is monitoring, but that's our future water supply, these aquifers, and we're poisoning it. So we

need to take -- if we want a gas plant, if we don't want the solar contract, we need to take responsibility for where this gas comes from. The other thing Austin energy said was the price of gas would remain low for a long period of time. That's old data. We have a really good study at the university of Texas that was released last year.
