AE 1-2. In 'Presentation on Revenue Requirement' on page 4 under footnote 8, please provide the supporting calculations for how these numbers were derived:

- a. 12.5%
- b. \$343,575,578
- c. 42.1%
- d. \$739,733,112
- e. 13%

RESPONSE:

See Attachment A, which provides the sources and calculations sought in AE 1-2(a)-(e). Pursuant. Pursuant to AE's Instruction E Data Foundry is also providing a separate electronic version of the native Excel spreadsheet that produced Attachment A.

SUPPLEMENTAL RESPONSE:

AE's counsel contacted Data Foundry's counsel on an informal basis to determine the location of the specific response to 1-2(b) on Attachment A. Data Foundry discovered that it had inadvertently failed to include a specific response to that request.

Data Foundry now supplements to indicate in response to 1-2(b) that the number "\$343,575,578" appearing in note 8 of Data Foundry's initial presentation included a typo. The third digit from the left used "3" rather than "1." The number should have been "\$341,575,538." This is evident from the fact that the relevant part of the note refers to AE's "alleged demand 'costs' ..."

Therefore, after correction of the typo, the source of the number is the same as for 1-1(a). See Figure 5.8, RFP p. 5-12; Sch D-8, l. 7, Col. A.
