

M/WBE Summary

Public notice was given for this solicitation, CLMC573 SAR WWTP Trains and A and B Blower Replacement, through the City's Vendor Connection web portal which resulted in 112 contractors receiving notification. 10 contractors obtained the bid documents and four bids were received and opened on March 22, 2016. None of the bids received were from MBE/WBE certified firms. Matous Construction, Ltd. submitted the lowest responsive bid of 4 bids received:
