BASIS FOR RECOMMENDATION:

Architecture:

One-story, wing-and-gable plan frame house with a partial-width inset porch on paired plain square wood posts and stone piers; transom over the glazed front door; large, non-historic picture window with sliding sashes in the bottom in the principal façade.

Historical Associations:

The house appears to have been built around 1903 by Green W. Griffin, a carpenter who later moved to a large house at 1202 Garden Street, and which has been designated as a

city historic landmark – the McGown-Griffin House. Green W. and Jessie Griffin lived in this house on San Bernard Street until around 1915. The house was then occupied by Rufus and Mamie Overstreet, who lived here from around 1917 to around 1919. Rufus Overstreet was a plasterer, and after living in this house, he moved to Houston. He returned to Austin at some point in the late 1920s – at the time of his death in 1932, he was living in Austin.

Beginning around 1923, the house made the transition from Anglo families to African-American families. Henry W. and Eva Walker are listed as the owners of the house in the 1924 city directory, which notes that they were African-American. Around 1928, the house was purchased by Lee Andrew and Beulah Murphy, who lived here until around 1946. Lee Andrew Murphy was a waiter at the Austin Country Club, while Beulah J. Murphy was a stenographer for Nathan Rhambo, who ran a mortuary and embalming service for Austin's African-American community. The 1940 U.S. Census shows Beulah Murphy as a lodger in the home of an African-American school teacher in Washington, D.C., where she was working as a stenographer in a private office. Lee Andrew Murphy is not listed in the 1940 census report.

From around 1950 until his death in 1965, Rev. Rogers Q. Allen, and his wife, Lonnie owned this house. Rev. Rogers Q. Allen was born in Caldwell County, Texas to a preacher, and took up the gospel himself throughout his life. In 1939, he established the Corinth Missionary Baptist Church on E. 16th Street in Austin, and served as its pastor until his death in1965.

From 1965 until the mid-1980s, when they passed away, the house was the home of Emmett and Dessie Washington, a retired couple.

I am Marva Griffin Carter, the owner of the house at 1175 San Bernard Street in Austin, Texas.





Green W. and Jessie H. Griffin (ca. 1903 – ca. 1915)

Green W. and Jessie H. Griffin appear in the 1900 U.S. Census at 900 E. 14th Street, a house they owned. Green W. Griffin was 33, had been born in Texas to Tennessee-born parents, and was a carpenter. Jessie H. Griffin was 27, had been born in Texas to Tennessee-born parents, and had no occupation listed. They had a daughter, Hazel, 6, who had been born in Texas.

The 1910 U.S. Census shows Green W. and Jessie H. Griffin as the owners of this house. Green W. Griffin was a 42-year old carpenter. Jessie H. Griffin had no occupation listed. Besides their daughter Hazel, 16, Green's brother Calvin, 44, lived with them. He was a carpenter.

The 1920 U.S. Census shows Green W. and Jessie H. Griffin at 1202 Garden Street (a city historic landmark – the McGown-Griffin House), which is listed as 83 Waller Street. They are shown as the owners. Green W. Griffin is shown as a carpenter. With them lived Green's brother, Calvin, an invalid.

The 1930 U.S. Census shows Green W. and Jessie H. Griffin as the owners of the house at 1202 Garden Street, which is listed as 83 Waller Street. The house was worth \$5,000. Green W. Griffin was a carpenter. Neither Hazel nor Calvin Griffin are shown in the census report. The Griffins roomers, Wiley W. and Ella Mangum. Wiley Mangum was a 58-year old, Georgiaborn night watchman at the compress. Ella Mangum was 54, had been born in Missouri, and had no occupation listed.

The 1940 U.S. Census shows Green W. and Jessie H. Griffin as the owners of the house at 1202 Garden Street, which was worth \$2,500. Green W. Griffin had no occupation listed. With them lived their daughter, Hazel Bach, and Hazel's husband, Alfred A. Bach, a 57-year old

Pennsylvania-born carpenter-contractor. Hazel had no occupation listed. Alfred and Hazel's 2 children also lived in the house: Margaret H. Bach, 27, a beautician in a beauty salon; and Alfred G. Bach, 17, who had no occupation listed. Both children had been born in Texas.

G. W. GRIFFIN G. W. (Tobe) Griffin, 95, of 1202 Garden Street, died in a local hospital Wednesday. He was a retired contractor and a deacon of East Avenue Baptist Church, where he had been a member for 65 years. Survivors include his widow. Griffin: daughter, Mrs. Annie Mrs. Hazel Bach of Austin: a step-son, Burnham Fallwell of granddaughters, three Austin: Mrs. Margaret Cook and Mrs. Mildred Huber of Austin. and Mrs. Jessie Mae Wise of Venezuela: grandson, Alfred G. Bach of Temple; and 7 great-grandchildren. Funeral services will be held Friday at 2 p.m. at Cook Funeral Home with Rev. E. L. Sparks officiating. Burial will be in Oakwood Cemetery. Pallbearers will be Sam Griffin. Gordon W. Griffin, M. Eugene Bounds, H. D. Reich Jr., Grover Griffin, Charles Morrison and W. A. Douglas.

Rufus and Mamie Overstreet (ca. 1917 – ca. 1919)

Rufus and Mamie Overstreet appear in the 1900 U.S. Census at 906 E. 14th Street. Rufus Overstreet was 35, had been born in Texas to Mississippi-born parents, and was a plasterer. Mamie F. Overstreet was 31, had been born in Texas, and had no occupation listed. They had 5 children: Rufus, 11; Freddie, 7; William, 5; Eula M., 3; and Joe, 1. With them lived Mamie Overstreet's brother, Richard Henderson, 22, who had been born in Texas, and was a day laborer.

The 1910 U.S. Census shows Rufus and Mamie Overstreet (spelled Oglestreet) at 900 E. 12th Street. Rufus Overstreet was a 43-year old house plasterer. Mamie's birthplace is now listed as Florida. The children living with them were Freddie, 17, a house plasterer; Eula, 13; Jodie, 11; Oscar, 9; Onie, 6; and Clemmie, 2.

The 1920 U.S. Census shows Rufus and Mary F. Overstreet living in a rented house in Houston, Texas. Rufus was a 54-year old house plasterer. Mary F. Overstreet was 51, had been born in Florida, and had no occupation listed. The children living with them were Joe, 20, a house plasterer; Clemmie, 12; and Richard, 9.

At the time of his death in 1932, Rufus Overstreet was living at 1612 E. 6th Street in Austin. He was born in 1864 in Texas, and was a plasterer.

Lee Andrew and Beulah J. Murphy (ca. 1928 – ca. 1946)

Lee Andrew and Beulah Murphy appear in the 1920 U.S. Census as the renters of an apartment at 814 E. 12th Street in Austin. Lee Andrew Murphy was 36, had been born in Texas, and was a butler for a private family. Beulah Murphy was 22, had been born in Texas, and had no occupation listed. They had no children listed with them.

The 1930 U.S. Census shows L.A. and Beulah J. Murphy as the owners of this house, which was worth \$3,000. L.A. Murphy was 42, had been born in Texas, and was a custodian at the Post Office. Beulah J. Murphy was 29, had been born in Texas, and was a stenographer and book-keeper for an undertaker.

Beulah J. Murphy appears in the 1940 U.S. Census for Washington, D.C., where she is listed as a lodger in the home of Alice H. Jackson, a widowed public school teacher. Beulah J. Murphy was born in Texas and lived in Austin in 1935. She was married, and worked as a stenographer in a private office. Her husband is not listed with her.

Rev. Rogers Q. and Lonnie J. Allen (ca. 1950 - ca. 1965)

Roger Allen appears in the 1900 U.S. Census for Caldwell County, Texas as the 9 year old son of James and Ella Allen. Roger had been born in Texas, and is the 5th of the couple's 7

children. Roger's father, James Allen, was born in Texas, and was a "minister of the gospel." Roger is listed as being at school.

His 1917 World War I draft registration card shows that Rogers Q. Allen was born in Lockhart, Texas on May 1, 1892 He was living at Del Valle in Bastrop County at the time of his registration and was engaged in farming. He was single, tall, and stout.

The 1930 U.S. Census shows R.Q. and Mary Belle Allen as the owners of a house on Route 5 in rural Travis County. R.Q. Allen was 36, had been born in Texas, and was a minister of a Baptist Church. Mary Belle Allen was 30, had been born in Texas, and had no occupation listed. They had no children listed with them.

The 1940 U.S. Census shows R.Q. and May Belle Allen as the owners of the house at 1703 Kinney Avenue in South Austin. R.Q. Allen was 41, had been born in Texas, and was a preacher. May Belle Allen was 38, had been born in Texas, and had no occupation listed. They had no children listed with them.

Corinth Missionary Baptist Church was organized on March 23, 1939 on the south corner of the present lot in a 12 x 12 room with 12 members present. Rev. R.Q. Allen was the moderator of the meeting. Rev. Allen was called as pastor that same night and he served as pastor of Corinth Missionary Baptist Church for 26 years.










The 1922 Sanborn map is the first to show the house. It has an address of 1173 San Bernard Street.
