# PROPOSAL

Demolish a ca. 1931 house.

## ARCHITECTURE

One-story, rectangular-plan, front-gabled frame bungalow with a central, partial-width, front-gabled independent porch on ornamental metal posts; single and paired 1:1 fenestration.

# RESEARCH


The house appears to have been built around 1931 by N.A. Dawson, whose family developed large areas of South Austin, as a rental property, and the house has been a rent house for its entire existence. The first tenants were William J. and Viola Cloer, who lived here until around 1934. William Cloer was a house carpenter. There was a very high turnover of tenants from that time forward, with no occupants renting the house for more than a year or two. Tenants were generally blue-collar, including an electrician, an auto trimmer, a carpenter, a lineman, a machinist, a clerk at a drug store, a truck driver, a plumber, a bookkeeper and his wife, who was a waitress, and in later years, students.

# STAFF COMMENTS

The house is beyond the bounds of any City survey.

# STAFF RECOMMENDATION

Encourage rehabilitation and adaptive re-use, but release the permit upon completion of a City of Austin Documentation Package, consisting of photographs of all elevations, a dimensioned sketch plan, and a narrative history, for archiving at the Austin History Center. The house has neither the architectural nor the historical significance to warrant individual designation as a historic landmark.

The 1930 U.S. Census shows William J. and Viola Cloer as the renters of the house at 1810 Nickerson. William J. Cloer was 51, had been born in Tennessee, and was a house carpenter.

Viola Cloer was also 51, had been born in Texas, and had no occupation listed. They had 3 children: Annie, 17, a helper in a book bindery; J.T., 21, an auto mechanic; and Milton, 15, a helper in a produce company. All of the children had been born in Texas. They also had a lodger, Emil Bernhard, 70, who had been born in Texas to German-born parents, and had no occupation listed.

His 1918 World War I draft registration card shows William Jonas Cloer as living at Lott, Falls County, Texas, where he was a self-employed farmer. He was born in 1876, was of medium height and build, and had blue eyes and gray hair.

WHIJAM J. CLOER Funeral services for William J. Cloer, 85, of 1906 Kinney Avenue. who died Tuesday will be held Thursday at 4 p.m. from Wilke Clay Funeral Home. Minister Dean Rhoades will officiate. Cloer had been a resident of Austin 31 years and was a member of Southside Church of Christ and a retired carpenter. He is survived by his widow Mrs. Viola Elizabeth Goer of Austin: three daughters, Mrs. Clifton Dye of Austin, Mrs. Ben Rosencran of San Antonio and Mrs. W. A. Burkett of Los Banos, Calif.: four sons, Barney, J. T., and Milton Cloer, all of Austin. and J. D. Cloer of Granger; a sister, Mrs. Irene Nix of Canadian City, and several grandchildren and great grandchildren. Pallbearers will be Billy Bob Dve. Alvin Cloer, Ronald Cloer. Bobby Luce, G. A. Moore Jr., and W. G. Rosencran. Burial will be in Capital Me--morial Gardens.

With them lived G.E.'s brother, Eric Almquist, 21, who was a Texas-born painter for a hotel company.

Also listed as renters at this address are G.L. and Marie Pope. G.L. Pope was 30, had been born in Texas, and was a salesman for an auto supply store. Marie Pope was 23, had been born in Texas, and had no occupation listed. They had 2 sons: James, 3; and Gwendel, 1, both of whom had been born in Texas.
