**Answer:** Work Paper E-4.3 Excel lines 11 and 24 shows the test year amount of the Transfer

to the Communications and Technology Management to be \$6,451,092. This compares to WP D-1.2.8.1, column E, row 4 of \$7,037,555 and a known and measurable adjustment (\$90,930.) The difference appears to be an overstatement of the Test Veer amount of \$586.462 which is not included in my recommended.

How does this differ from the 726 MW Capacity for Decker Units 1 and 2 referenced in Appendix I, Bates Stamp 526, of Austin Energy's 2015 Cost of Service Study and Proposal to Change Base Electric Rates – Appendices?

## Answer:

The calculation contains a typo. The capacity should be 726 MW. The corrected calculation is understated by \$87,000 for a three year period or \$29,000 annually. This does not change my revenue requirement because my recommendation is to allow this amount in reserves which are already overfunded.
