

ORDINANCE NO. 20160519-040

AN ORDINANCE WAIVING OR REIMBURSING CERTAIN FEES AND REQUIREMENTS UNDER CITY CODE CHAPTER 14-8, AND AUTHORIZING CERTAIN OTHER FEES AND REQUIREMENTS, AND AUTHORIZING PAYMENT OF CERTAIN COSTS FOR THE CITY CO-SPONSORED 2016 JUNETEENTH PARADE AND CELEBRATION TO BE HELD ON JUNE 18, 2016.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

PART 1. The City co-sponsored 2016 Greater East Austin Youth Association's 2016 Juneteenth Parade and Celebration to be held on June 18, 2016, along East Martin Luther King, Jr. Boulevard, Comal Street, and Rosewood Avenue with a celebration at Rosewood Park.

PART 2. Council waives or reimburses certain fees and requirements, and authorizes payment of certain costs for the 2016 Juneteenth Parade and Celebration as follows:




