## 1. CALL TO ORDER

a. Chair Michael Jones called the meeting to order at 6:05 p.m.

#### 2. CITIZEN COMMUNICATION: GENERAL

## 3. BRIEFINGS

a. <u>Mueller Parking and Transportation Management District (PTMD):</u> Dee Desjardin (Catellus), Jill Fagan (EDD), Ravi Dhamrat (Austin Transportation Department) and Amica Bose (ATD) provided an overview of the PTMD previously established for Mueller and an update on current items, including on-street paid parking implementation in the Town Center.

# 4. OLD BUSINESS

- a. <u>Mueller Affordable Housing/TCAD Update</u>: Patti Summerville with the Mueller Foundation provided an update on the status of the ongoing discussions regarding the Travis County Appraisal District (TCAD) appraisals for affordable homes at Mueller.
- b. <u>AISD Imagine Northeast Austin/School Site at Mueller Update:</u> Dee Desjardin provided a brief update and shared information from the recent AISD board work session dialogue on the larger northeast Austin area and need for continued community engagement.
- c. <u>PIAC Working Group on Density Update:</u> Commissioners provided a brief update on their first Working Group meeting and next steps, including requested documents from staff and Catellus related to Mueller's Traffic Impact Analysis (TIA).

- a. Officer Elections: Commissioners took nominations and held elections for the following officers:
  - i. Commissioner Jones was voted Chair on Commissioner Hilliard's nomination and Commissioner Drennan's second on an 11-0 vote.
  - ii. Commissioner Krivoniak was then voted Vice-Chair on Commissioner Miller's nomination and Commissioner Mick's second on an 11-0 vote.
- b. <u>Mueller Development Update</u>: Dee Desjardin shared information on the groundbreaking for the new workforce housing multifamily project by DMA and the announcement of the Texas Mutual Insurance headquarters to be built at Mueller; Dee also provided updates on the status of streets under construction, new residential sections, and John Gaines Park.
