

## M/WBE Summary

Public notice was given for this solicitation, CLMC581 Retired Facility Decommissioning Phase B, through the City's Vendor Connection web portal which resulted in 511 contractors receiving notification. Twelve contractors obtained the bid documents and five bids were received and opened on April 14, 2016. Only one out of the five bids received was a certified MBE/WBE firm. MA Smith Contracting Company, Inc., Austin, TX submitted the lowest of five bids received:
