Amount and Source of Funding				
<p>Funding in the amount of \$430,685 is available from the Texas Automobile Burglary and Theft Prevention Authority for the project period of September 1, 2016 – August 31, 2017. The City match of \$212,373.57, approximately 33% of the total project cost, will be met by accounting for the base salary and fringe benefits of existing City positions.</p>

<p>This action will provide the resolution required by the Texas Automobile Burglary and Theft Prevention Authority to apply for and accept \$430,685 in grant funding. The resolution approved by council must be attached to the City of Austin grant application, which is due June 30, 2016.</p> <p>The resolution must:</p> <ul style="list-style-type: none"> • Provide authority to apply for the grant; • Provide that funds will be returned in the event of loss or misuse; and, • Designate the Authorized Official (Assistant City Manager), Financial Officer (APD Chief Financial Manager) and Project Director (APD Property Crimes Lieutenant). <p><i>According to the ABTPA, the designation of officials means we should provide the title of the person assuming the role of each official. It is allowable to include names but if we do so and there is turnover, we will need to provide ABTPA an updated Council resolution.</i></p>				

The budget for the September 1, 2016 – August 31, 2017 project period includes: personnel (\$361,070), fringe (\$54,445), training costs (\$1,475), and supplies (\$13,695). The City match of \$212,373.57, approximately 33% of the total project cost, will be met by accounting for the base salary and fringe benefits of existing City positions assigned to the project.

The Austin Police Department has partnered with the Texas Automobile Burglary and Theft Prevention Authority since the late 1990's. With the assistance of ABTPA grant funding, the APD Auto Burglary and Theft Interdiction Project has been successful in implementing a variety of strategies to reduce auto thefts, recover stolen vehicles, and prosecute offenders. Proactive crime analysis assists in identifying problems involving commercial auto thefts and in targeting "theft for profit" offenders. Examples of commercial auto theft activities occurring in Austin, Travis County include VIN switches, vehicle cloning chop shops, illegal part dealings and international smuggling operations. Growth in population, registered vehicles and continued annexations to the city generate an increased number of vehicles, naturally leading to additional opportunities for criminal activity.
