PROPOSAL

Demolish a house that was moved onto this site ca. 1969 from an unknown location.

ARCHITECTURE

One-story, rectangular-plan, side-gabled frame house with a shed-roofed entry hood; single 1:1 fenestration; attached shed-roofed carport.

RESEARCH

This house was moved onto the site in 1969, replacing an older house that had been moved onto this site from E. 15th Street in 1948. That older house was demolished in 1969 and this house was moved onto the lot. Cal and Arvella (“Ella Six”) Jackson lived here from the time the house was moved onto the site until their deaths – Cal died in 1980; Arvella died in 1984. The house was then rented out.

STAFF COMMENTS




The house does not appear in any City survey to date.

STAFF RECOMMENDATION

Encourage relocation over demolition, but release the permit. The house was moved onto the site in 1969 and its history prior to that time is unknown.

BIOGRAPHICAL NOTES

Cal and Arvella Jackson (ca. 1972 – ca. 1984)

According to his 1980 death certificate, Cal Jackson was born in 1889 in Texas. He was a 91-year old retired gardener who did yard work. He was living in this house at the time of his death. His widow was Arvella Williams Jackson.

JACKSON, Cal 91, 2010 E. 20th St., died Sunday. Services 11 a.m. Saturday at King-Tears Mortuary. Burial, Williams Cemetery in Bastrop County. Survivors: wife, Arvella "Ella" Jackson of Austin; daughters, Doris Mackey, Evelyn Porter, both of Austin; son, Vernon Jackson of Houston; three grandchildren; four great-grandchildren.
