HISTORIC LANDMARK COMMISSION JUNE 27, 2016 DEMOLITION AND RELOCATION PERMITS HDP-2016-0407 4615 LYONS ROAD

PROPOSAL

Demolish a ca. 1948 house.

ARCHITECTURE

One-story, cross-gabled frame house with a partial-width, front-gabled partially-inset porch on ornamental metal supports; single, paired, and triple 1:1 fenestration.

RESEARCH

The house may be older than 1948 because this area was outside the city limits in the 1940s so there may additional documents regarding its actual date of construction, but the architectural style and proportions of this house seem to support a ca. 1948 construction date.

The first known occupants of the house were Frank and Carolyn Veselka, who lived here until around 1951. Frank Veselka had an auto supply store on East Avenue. Gladden and Dorothy Hibler rented the house in the early and mid-1950s; he worked for Pannell Electric Motor Service in the early 1950s, then established Hibler Refrigeration Service in the mid-1950s. Dorothy Hibler worked as a clerk at the Austin National Bank. The house was rented to J.B. and Faye Lyons in the late 1950s; he was a truck driver for Central Freight Lines.

From around 1960 on, members of the Espinosa (or Espinoza) family have lived here, beginning with Gilbert and Guadalupe Espinoza. Gilbert Espinoza had a barber shop. After his death in the mid-1960s, his widow continued to live in this house. A son, Raymond, who worked as a janitor, was listed as the occupant through the 1980s and early 1990s.


STAFF COMMENTS

The house is beyond the bounds of any City survey.

STAFF RECOMMENDATION

Encourage rehabilitation and adaptive re-use, then relocation over demolition, but release the permit upon completion of a City of Austin Documentation Package, consisting of photographs of all elevations, a dimensioned sketch plan, and a narrative history, for archiving at the Austin History Center. The house has neither the architectural nor the historical significance to warrant individual designation as a historic landmark.
