BUILDING AND STANDARDS COMMISSION

The Board/Commission mission statement is:

The Building and Standards Commission was established to hear cases concerning alleged violations of the City's housing and dangerous building regulations.

The Building and Standards Commission shall have the powers and duties and comply with the procedures established by Texas Local Government Code, Chapter 54, Subchapter C (*Quasi-Judicial Enforcement of Health and Safety Ordinances*), and Chapter 25-12, Article 9 (*Property Maintenance Code*) of the Austin City Code.

- 1. Describe the board's actions supporting their mission during the previous calendar year. Address all elements of the board's mission statement as provided in the relevant sections of the City Code.
 - The Panel 1 Commission met on **10** occasions to hear cases involving, appeals, and substandard / dangerous properties.
 - Full Commission, Panel 1 and 2 held meetings on 2 occasions, **September 23, 2015** and **December 16, 2015**.
 - The Commission heard a total of **50** new cases.
 - The Commission heard a total of **11** returning cases
 - The Commission heard 4 updates on 1124 Rutland Dr. Cross Creek.
 - The Commission meetings scheduled for 01/20/2016, 01/13/2016, 12/9/2015, 12/8/2015, 12/3/2015, and 09/3/2015 were cancelled.
 - Funds collected for liens for demolition of substandard/dangerous structures for FY 2015 10/1/2014 to 9/30/2015, and FY 2016 -10/1/2015 to 5/31/2016: **\$ 81,181.92**

Funds collected for penalties in non-compliance cases of substandard/dangerous structures for FY 2015 - 10/1/2014 to 9/30/2015 and FY 2016 – 10/1/2015 to 5/31/2016: \$ 323,101.88

2. Determine if the board's actions throughout the year comply with the mission statement.

- The Commission issued **23** demolition orders.
- The Commission issued **27** repair orders.
- The Commission heard **12** appeals.
- The Commission issued 3 modified repair orders.
- The Commission issued 2 modified demo orders.
- The Commission issued **6** reduced civil penalties orders.
- The Commission has complied with its mission to hear and act on cases pertaining to substandard and dangerous structures in the City.
- The Commission's actions directly resulted in eliminating substandard and dangerous conditions at properties throughout the City.

3. List the board's goals and objectives for the new calendar year.

- Staff will coordinate a Building and Standards Commission retreat.
- Staff will attempt to increase the number of cases heard by the Commission.
- Staff will attempt to increase number of Commission hearings to a Bimonthly hearings
- Staff will modify presentation to the Commission in order to be more effective.
- Staff will coordinate ride-a-longs for Commissioners for first-hand observations of substandard and dangerous structures.
