# PROPOSAL

Demolish a ca. 1964 house.

# ARCHITECTURE

One-story, rectangular-plan, side-gabled brick veneered frame house with an extended eave forming a front entry and carport; single and paired 1:1 fenestration.

## RESEARCH

The house was built in 1964. The first owners and occupants were Presley J. and Ruth L. Willis, who lived here for the rest of their lives. Presley Willis was a driver and equipment operator for the City Parks and Recreation Department. Ruth Willis died in 2003; Presley Willis died in 2011.

# STAFF COMMENTS


The house is beyond the bounds of any City survey.

# STAFF RECOMMENDATION

Encourage rehabilitation and adaptive re-use, but release the permit upon completion of a City of Austin Documentation Package, consisting of photographs of all elevations, a dimensioned sketch plan, and a narrative history, for archiving at the Austin History Center. The house has neither the architectural nor the historical significance to warrant individual designation as a historic landmark.
