HISTORIC LANDMARK COMMISSION JULY 25, 2016 DEMOLITION AND RELOCATION PERMITS HDP-2016-0458 901 WEST AVENUE

PROPOSAL

Almost total demolition of a ca. 1902 house to construct a second story addition and additional ground-floor space.

ARCHITECTURE

The existing house is a one-story, square-plan, pyramidal-roofed frame house with what appears to be a non-historic gabled entry hood on the West Avenue side; single 1:1 fenestration; diamond-paned sidelights and transom at the main door. City building permits show that a full-width porch on the south side of the house was enclosed around 1945.

RESEARCH

The house is believed to have been built around 1902, and the 1900 Sanborn map appears to show another house on this site. The history of this site prior to 1902 is unknown. The first known occupants of this house were Charley and Mary Schwarzer, who lived here until 1908. Both Charley and Mary Schwarzer had been born in Germany, and immigrated to the United States with their oldest child in 1881. Charley Schwarzer is listed as a draftsman. An adult son, George, lived with his parents in this house; George Schwarzer was a pressman for Von Boeckmann-Jones, a local printing and bookbinding company.

Jeff S. Wimbish, who owned a drug store on Congress Avenue, and his wife, Sadie, lived here from around 1911 to around 1919. The Wimbish family then moved to Dallas by 1920, where Jeff Wimbish died in 1922.

Arno W. Brill, Jr. and his wife, Kathleen, owned and occupied this house in the 1930s. Arno W. Brill, Jr. was the son of A.W. Brill, a leather maker and dealer (whose home on W. 9th Street is a city landmark). Arno W. Brill, Jr. worked for his father as a salesman, both in the store at 302 E. 6th Street, and traveling.

From around 1951 until his death in1999, the house was occupied by Edward and Helen Nassour. Ed Nassour had a number of jobs while living in this house, including work for the IRS, while Helen worked for the telephone company as an operator. Ed eventually went to work in his family's liquor business as a salesman and distributor.


STAFF COMMENTS

The house is listed in the Comprehensive Cultural Resources Survey (1984) as a Priority 2 for research.

STAFF RECOMMENDATION

While staff contends that the proposed building project violates almost every philosophy of historic preservation in its obliteration of this house, we have to look at whether the house truly qualifies as a historic landmark, and staff does not believe that does. The house has some architectural significance, but has been modified over the years to its current configuration, it is in poor condition, and the historical associations do not appear to rise to the level of individual designation as a historic landmark, so staff must reluctantly recommend release of the permit upon completion of a City of Austin Documentation Package, consisting of photographs of all elevations, a dimensioned sketch plan, and a

narrative history, for archiving at the Austin History Center, and to counsel the owner to seriously reconsider his plans for this house to design an addition that will complement rather than obliterate the existing house.

BIOGRAPHICAL NOTES

Charlie and Mary Schwarzer (ca. 1902 – ca. 1908)

The 1900 U.S. Census shows Charles and Mary Schwarzer at 609 W. 16th Street. Charles Schwarzer was 51, had been born in Germany, and was a draughtsman. Mary Schwarzer was 53, had been born in Germany, and had no occupation listed. They had 4 children: George, 30, who had been born in Germany, and was printer; Annie, 17, who had been born in Texas; Willie, 15, who had been born in Texas; and Elizabeth, 7, who had been born in Texas. The German-born members of the family had immigrated to the United States in 1881.

The 1910 U.S. Census shows Charley and Mary Schwarzer at 506 W. 10th Street. Charley was a 61-year old turfsman [?]. None of their children still lived with them.

Jeff and Sadie Wimbish (ca. 1911 – ca. 1919)

The 1910 U.S. Census shows Jeff S. and Saidie WImbish at 1113 W. 9th Street. Jeff Wimbish was 33, had been born in Texas, and was a druggist with his own drug store. Saidie Wimbish was 32m was born in Mississippi, and had no occupation listed. They had 2 children: Ellen, 3; and John W., 1, both of whom had been born in Texas. In addition, they had a servant, John A. Hood, an 18-year old African-American who had been born in Texas, and is listed as their yard boy.

His 1918 World War I draft registration card shows that Jeff Shirley Wimbish was born in 1876, and was living in this house. He was in the drug business at 308 Congress Avenue. He was of medium height and had a slender build, blue eyes, and brown hair.

The 1920 U.S. Census shows Jeff S. and Sadie Wimbish living in a rented house in Dallas, where Jeff was a druggist. In addition to Ellen and John, they had 2 younger children: Francis, 7; and Mary, 5.

Jeff Wimbish died in 1922 and is buried in Carthage, Mississippi.


Arno W., Jr. and Kathleen Brill (ca. 1930 – ca. 1938)

The 1930 U.S. Census show Arno and Kathleen Brill as the owners of this house with its address of 901 West Avenue. The house was worth \$5,000. Arno Brill, Jr. was 33, had been born in Texas, and was a wholesale leather dealer. Kathleen Brill was 30, had been born in Texas, and had no occupation listed. They had 5 children: Ida Nell, 11; Billie, 9; Sheba, 6; Bob, 4; and A.W, III, 1. All the children had been born in Texas. The family had a maid, Olivia Dremwelge, 17, who had been born in Texas.


The 1940 U.S. Census shows Arno W. and Kathleen Brill at 713 W. 14th Street in Austin. Arno W. Brill was 43, had been born in Texas, and was a wholesale and retail leather salesman. Kathleen Brill was 40, had been born in Texas, and had no occupation listed. They had 4 children: Idanell, 21; Sheva (Kathleen), 16; Bob, 14; A.W., 11; Bill, 19, and Bill's wife, Mary Jo, 20. Bill and Mary Jo had a daughter, Barbara Ann, 1. All of the children had been born in Texas, and none had an occupation listed. In addition, Kathleen Brill's mother, Nellie Inks, a 78-year old Arkansas-born widow, lived with them, as did Kathleen's brother, Lee O. Inks, 37, who had been born in Texas, and had no occupation listed.

Edward and Helen Nassour (ca. 1951 – ca. 1999)


Edward Nassour appears in the 1940 U.S. Census as the 22-year old son of Abraham and Amelia Nassour, who lived at 407 E. 7th Street. Edward Nassour was born in Texas and had no occupation listed. His father, Abraham, 57, had been born in Syria (now Lebanon), and was the owner of a retail grocery store. His mother, Amelia, 48, had also been born in Syria (now Lebanon) and was a saleslady in a retail grocery store. Edward was the second oldest of the couple's 4 children, all of whom had been born in Texas.




The 1900 Sanborn map shows a house with the address of 706 W. 9th Street with a front porch facing 9th Street.



The 1935 Sanborn map shows a full-width front porch on the south side of the house and a smaller porch facing West Avenue. The footprint of the house is different from that shown on the 1900 map above.
