#### PROPOSAL

Demolish a ca. 1953 house.

#### ARCHITECTURE

One-story, rectangular-plan, front-gabled frame house with a partial-width inset porch; brick veneer wainscot at the front of the house; single 2:2 horizontally-configured fenestration.

#### RESEARCH


There is no building permit on file for this house, which has the configuration of a much earlier house, but city directory research did not reveal any listings for this address earlier than the early 1950s. The house was first occupied by Bertha Webb, a waitress at the Night Hawk restaurant. Bertha Webb lived here until around 1957. The house was then owned and occupied by Willie T. and Bernice H. Jones, who lived here until the mid-1960s. Willie T. Jones was a helper at the Twin Oaks Cafeteria, then later worked as a porter at the Bank of Austin. From the mid-1960s onward, the house was owned and occupied by Jose and Maria G. Muniz. Jose Muniz worked a variety of construction jobs early in his occupancy of this house, then went to work for Woodward, Inc., which later became Broyhill Furniture.

## STAFF COMMENTS

The house is not listed in any City survey.

#### STAFF RECOMMENDATION

Release the permit. The house has neither the architectural nor the historical significance to warrant individual designation as a historic landmark.
