## **Library Commission**

#### This Year's Goals

- 1. Using the city council districts, commissioners will be assigned specific branches and will serve as liaisons to those branches.
- 2. Inform our respective city council member about major issues facing the Library.
- 3. Be well informed about the Library operations and the New Central Library to answer questions from the public and our city council member representative.
- 4. Strengthen relationships with the Austin History Center Association (AHCA) and the Austin Public Library Friends Foundation (APLFF).
- 5. Create a strategic plan of major areas of interest by having a retreat to give each commissioner an opportunity to share what areas of the Austin Public Library are of interest to them and will provide them the opportunity to better represent their council district and keep their council representative more informed.

### **Operations**

Commissioners created a schedule of monthly meetings for the year to be held at the Austin History Center and various branches.

Commissioners visited assigned libraries and attended library events.

Commission Chair is serving as a liaison the Austin Public Library Friends Foundation.

Selected winners for the Austin Public Library Employee Awards and attended the awards event in April 2016.

Commissioners communicated with their city council members regarding major issues.

Commissioners drafted a Recommendation to the Cap Metro Board to request the relocation of the bus stop in front of the Austin History Center.
