A request has been received from Terry Holley on behalf of Kent Savage to construct a boat dock at 1500 Rockcliff on Lake Austin.







BULKHEAD NOTES:

1. BULKHEAD CONSTRUCTION SHALL BE LAWFULLY INSTALLED.

2. THE CITY OF AUSTIN GENERAL CONSTRUCTION NOTES ARE MADE A PART OF THIS PROJECT FOR APPLICABILITY IN THE EVENT THAT UNFORSEEN DISTURBANCE OF THE LAND AREA OF THE SITE (OUTSIDE OF THE ONGOING HOME CONSTRUCTION) IS NECESSARY TO COMPLETE THE APPROVED CONSTRUCTION. REFERENCE: EXHIBIT III OF THE BOAT DOCK PACKET (5/24/91) AND SILT FENCE DETAIL; FIGURE 1-8, C THE ENVIRONMENTAL MANUAL.

3. NO TREES SHALL BE REMOVED DURING THE CONSTRUCTION OF THE BULKHEAD. FILL AROUND TREES WITHIN THE CRZ SHALL BE LIMITED TO 0.5 FEET.

- 4. THE BULKHEAD SHALL BE IN PLACE PRIOR TO ANY FILL PLACEMENT.
- 5. TEMPORARY EROSION CONTROLS SHALL CONSIST OF THE BULKHEAD AND SILT FENCE
- 6. FILL AREAS SHALL BE REVEGETATED WITH ST. AUGUSTINE SOD OR APPROVED EQUAL.
- 7. CONSTRUCTION PROPOSED DURING MAY 2001.






