


SITE IMPROVEMENT DATA

SUBJECT: Meeting with the Land & Facilities Committee of the Parks Board

TO: All interested parties, including members of the Land & Facilities Committee

Ladies & Gentlemen my name is J. A. Farrand, and I'm Vice-President of the Senior Activity Center - Lamar Guild, Inc. Board of Directors.

I would like to take this opportunity to thank Mrs. Castleberry for inviting me to attend one of your meetings, and to Mr. Strong for inviting me to attend this meeting in order to give me the privilege of outlining to this committee the plans we have for enhancing the facilities at the Senior Activity Center at 29th & Lamar.

As the result of an extremely generous gift of over \$300,000 by Mrs. Edith Christine Carter Davis, whose will stated, and I quote: "I hereby give, devise & bequeath all of my property, real, personal or mixed, which I may own at the time of my death, howsoever by me obtained and whatever nature description and form it may be in, unto the Senior Activity Center, located at 29th street and Lamar Street, Austin, Texas to be used for the benefit of Senior Activities at 29th Street & Lamar Street." In a codicil a few years later she specified that this gift be given to the Senior Activity Center - Lamar Guild, Inc. with the same specific guidelines as outlined in her will.

The Guild is a non-profit organization under the purview of Sect 501 (c) (3) as determined by the Internal Revenue Service as a charitable & educational organization.

One of the criteria as a charitable organization is to "lessen the burdens of government."

As you will see in my presentation, that is exactly what I'm trying to do.

In an attempt to offer the opportunity for computer literacy to the Senior Citizens of Austin, the Guild of the Senior Activity Center has sought since January 15, 1999 to have a computer classroom added to the existing facility. While we have not been successful in getting the addition approved - for a variety of reasons, some of which were our own doing - we were able to convert (with the assistance of PARD) a room to a computer

classroom. However, this was done at the expense of some of our members, and with the room addition we could provide the standard benefits the members have previously enjoyed.

Our rest room facilities are NOT ADA approved. If we do not correct this deficiency very soon there is a likelihood that the Center would have to be closed while the remodeling is done; thus depriving some 3,000 + senior citizens of Austin the availability of the Center.

In April 2000 Stuart Strong estimated the cost of the computer room (22 x 22) to be \$165,000. If the bathrooms were added, the cost estimate would be \$246,000. Folks, that equates to a price of \$341.00 a square foot. for the room addition, and \$253.00 a square foot for the rest room facility.

Having been a Purchasing & Contracting Officer for the Federal Government for approximately 20 years before my retirement, I felt these prices were exorbitant. My fellow Board members agreed, and asked Mr. Strong for a meeting.

On the 10th of July 2000, Mr. Strong had a meeting with us and said that the construction cost of the room addition was estimated to be \$150.00 a square foot and that the balance was for various fees charged by the city. That means that over 50% of the cost is in fees alone.

Based on Mr. Strong's figures - we know Mr. Strong was just a carrier of someone else's figures - the actual cost of the room addition and rest room facilities would be \$120,600. We believe this is still a little high, but we'll use them for planning purposes. We will add the architectural fees, to include the supervision of construction contract, which should total about \$20,000. Or a total cost of about \$140,600.

I have been authorized by the Board of Directors to commit up to \$144,000 for the construction of the room addition, rest room facilities, architectural fees, and supervision by the architect of the construction. We believe this should more than cover the cost of this project.

Since the architect, J. Robinson & Associates, had been highly recommended by Mr. Olivares, and continues to do work for the city, the Guild felt the Mr. Robinson would be an excellent choice to fill our A. & E. needs. Since we plan to have Robinson supervise the construction, his knowledge of the city code and other building requirements would appear - to us - to have "all the bases covered" necessary to comply with all the building requirements.

At the present time we are working on a Parkland Agreement with the City, which cannot be finalized until this committee & the Parks Board give their blessing to this project.

A portion of this agreement states that the City shall waive - or pay - for all municipal fees necessary to construct and place the improvements.

We hope that you will agree with this project and that you will also agree that we are doing all we can to enhance the facility at 29th & Lamar at no cost to the City.

At today's meeting of the Land and Facilities Subcommittee Meeting, Rosemary asked me to send an e-mail summarizing the subcommittee meeting and recommendation on this item so she can give to Board Members at the next full Board meeting. The subcommittee meeting was attended by Mary Ruth Holder, Rosemary Castleberry and Amy Babich as well as Stuart Strong and Donna Bohls of PARD staff, Richard Kroger of Transportation, Planning and Sustainability and Jim Christianson representing the West Enfield neighborhood association who made presentations and offered comments. Mr. Kroger said his department is still willing to pay the tree costs (estimated at around \$6,000 to \$8,000) for the large Cedar Elms cut as part of the project and is considering paying PARD for the value of the easement (no figure at time of meeting) on the parkland taken for the project. Mr. Kroger restated that the project is related to easing congestion not to address safety issues in this area and that no improvements will be made for pedestrian safety other than adjusting "walk" lights. The project may also increase traffic in the area but that is unknown at this time. Mr. Christenson explained that the neighborhood is opposed to this project and that they have not been kept informed of the plans or public meetings to allow them to address the project. After discussing the lack of public notice and comment opportunities for this project, Stuart Strong said PARD will put up signs in the parkland (Pease and Caswell) informing the public of a hearing before City Council on August 23rd for the taking of parkland required by Texas Parks and Wildlife Code Chapter 26. Based upon a motion by subcommittee chair Holder, the subcommittee recommended that the full Board recommend to Council to disapprove the addition of a left turn lane in the northbound lane of Lamar at the intersection of 24th Street that will result in the taking of dedicated parkland at the Caswell Tennis Center, the removal of several large trees alongside the Caswell Tennis Center and the addition of a 100-foot long retaining "cut limestone appearance" retaining wall alongside the Tennis Center grounds along Lamar and a 110 to 120-foot long retaining wall alongside the Tennis Center along 24th Street. The recommendation was based upon the subcommittee's feeling that taking of dedicated parkland and the trees on it (that provide respite, shade and calming effect for park goers, pedestrians in the area, as well as people driving through the park area) was not justified by a project based upon commuter convenience and not on safety. Tree removal and the installation of the two retaining walls and the increase in street width will dramatically change the character of this park area. The subcommittee is also concerned about the potential to increase traffic in this location and the lack of a meaningful enhancement for pedestrian and parkgoer use of the area. The subcommittee was also concerned about the lack of information. that has been given to neighbor, pedestrian and park-goer stakeholders and the lack of meaningful opportunities for their input into the development of this project. The subcommittee feels that its role is to protect the parkland and that members of the public will likely greet the taking of parkland for this project with dismay.

Dear Neighborhood Representative:

Transportation Systems Management (TSM) intersection projects are intended to provide improvements at congested intersections to reduce time spent waiting to get through an intersection. This typically involves adding right or left turn lanes at intersections, and sometimes a through lane.

The intersection of Lamar Boulevard and 24th Street experiences high levels of congestion, especially in the evening peak traffic period. Computer modeling of the intersection indicates that the best improvement to reduce traffic congestion at this location is to provide an additional northbound left turn lane on Lamar Boulevard. We counted 505 vehicles making this left turn from northbound Lamar Boulevard to westbound 24th Street in one hour of the evening peak traffic period. With the addition of another turn lane, we can reduce the long left turn arrow given this movement and reallocate the green time to other movements at the intersection, reducing travel delay, fuel consumption, and air pollution for everyone travelling through the intersection. Neighborhood associations were invited to a meeting regarding this project that took place on May 17, 2000. At that time, we had a preliminary drawing showing that Lamar Boulevard would need to be widened by one lane on the east side, though we were not certain at the time if all the widening would occur on the east side. We now have completed plans for the project that show widening on the east side of Lamar Boulevard on Caswell Tennis Center property. This will require the use of approximately 1/6 acre of parkland. We have preserved most of the trees on the lower slope of Caswell Tennis Center property, but have not been able to avoid the removal of four cedar elm trees ranging from 8 to 14 inches in diameter. Enclosed with this letter are two drawings showing the planned improvements. Sheet 1 shows the additional northbound left turn lane and widening of Lamar Boulevard by 11 1/2 feet at 24th Street, tapering to meet the existing curb at Shoal Creek Boulevard. The shaded area is affected parkland, and the trees that would be removed are shown. Sheet 2 shows reconstruction of the short southbound left turn bay north of 24th Street to make it longer.

I'd appreciate it if you would pass this information along to the folks in your neighborhood and encourage them to comment.



Resolution About Capital Metro Bus Stops and Bus Service to Zilker Park and Barton Springs Pool

WHEREAS Zilker Park and Barton Springs Pool are major destinations for Austin citizens, especially on weekends, and

WHEREAS Capital Metro Bus 30, which serves Zilker Park and Barton Springs Pool, runs at intervals ranging from 35 to 47 minutes on weekends, even less frequently than it runs on weekdays, and

WHEREAS the bus stops on Barton Springs road in Zilker Park have no shelter from sun or rain and no sidewalks, and only one of the two has a bench to sit on, and

WHEREAS both Zilker Park and Barton Springs road are already filled to overflowing with cars on weekends, and

WHEREAS many low-income people, elderly people, people with children, and people with disabilities depend on the Capital Metro bus for transportation to and from the park, and

WHEREAS it is not easy for people with disabilities or people with small children to use the buses and the bus stops in their present condition. and

WHEREAS the general public could be persuaded to use the bus to visit the park on weekends, if the bus ran more frequently and the bus stops were more comfortable and convenient,

NOW, THEREFORE, BE IT RESOLVED that the Austin Parks and Recreation Board recommends to the Austin City Council members who serve on the Capital Metro Board that they do all in their power to persuade Capital Metro to accomplish the following.

- (1) Add a bus stop to the Bus 30 route, so that the bus stops at the front gate of Barton Springs Pool, instead of dropping pool visitors a quarter mile away on Barton Springs Road.
- (2) Provide bus service to and from Barton Springs pool at intervals of no more than 10 minutes on weekends, from 6 AM too 10 PM.
- (3) Increase bus frequency on weekdays to at least once every 20 minutes.
- (4) Provide both bus stops on Barton Springs Road with shelters. benches, and bicycle racks (available free from the City of Austin Bicycle Program).
- (5) Provide a sidewalk or a granite gravel trail connecting the bus stops with the hike and bike trail.
- (6) Upgrade the bus stops and bus service at McBeth Recreation Center, as recommended by the Board of McBeth Recreation Center.

Parks and Recreation Board Resolution Supporting City Historic Landmark Designation for Deep Eddy

WHEREAS, Deep Eddy is an important historic park containing Deep Eddy pool and bathhouse, facilities that have been used and enjoyed by generations of Austinites; and

WHEREAS Deep Eddy qualifies as a City Historic Landmark based upon its 99 plus year history as a publicly accessible swimming and bathing hole, its progressive 1935 bath house design and Depression-era assisted construction, and its cultural and historical significance as a community recreation grounds; and

WHEREAS, designation as a city historic landmark would preserve the park's historic features, such as the bath house and pool for future generations of Austinites; and

WHEREAS historic landmark designation would not restrict the use of the park but would provide design review and guidance for physical changes; and

WHEREAS historic landmark designation would make the park eligible for federal, city and private historic preservation grants for restoration work, particularly for the much needed expeditious restoration of the bath house;

NOW, THEREFORE, BE IT RESOLVED, that the Parks and Recreation Board supports City Historic Landmark Designation for Deep Eddy, recommends that the Planning Commission and the City Council approve this designation for Deep Eddy and that the City of Austin pursue historic grants for the preservation of Deep Eddy and restoration of the bath house.
