

## M/WBE Summary

Public notice was given for this solicitation, CLMC585 Davis Water Treatment Plant Power Distribution Upgrade, through the City's Vendor Connection web portal which resulted in 507 contractors receiving notification. Four contractors obtained the bid documents and three bids were received and opened on May 26, 2016. One out of three bids received was certified MBE /WBE. T Morales Company Electric & Controls, Ltd. submitted the lowest responsive bid of 3 bids received including a \$1,450,000 allowance:

The contractor's choice of work methodology provides for 29 areas of subcontracting opportunities which are listed below. Project-specific subgoals stated in the solicitation were 0.57% African American; 1.58% Hispanic; 1.09% Native/Asian; and 1.95% WBE. The Contractor submitted a MBE /WBE Compliance Plan that met the goals of the solicitation and was approved by the Small and Minority Business Resources Department. Total participation estimated on compliance plan base bid amount of \$25,080,000:
