The increased fees will be used to fund existing services, expand the organics residential collection program, as well as continue ARR Master Plan activities.

An Austin Resource Recovery residential customer with a 64 gallon trash cart will experience a monthly increase of \$2.31 in their billing from \$30.95 to \$33.26.

An Austin Resource Recovery commercial customer with a 96 gallon trash cart will experience a monthly increase of \$0.31 from \$63.30 to \$63.61.
