

M/WBE Summary

Public notice was given for this solicitation, CLMC588 Austin Convention Center Parking Garage Repairs at 201 E. 2nd St. and 601 E. 5th St. project, through the City's Vendor Connection web portal which resulted in 320 contractors receiving notification. Twenty-one contractors obtained the bid documents and five bids were received and opened on June 16, 2016. One out of five bids received were certified MBE/WBE. One firm was found non-compliant and two firms were non-responsive. Restek, Inc. submitted the lowest responsive bid of five bids received:
