PROPOSAL

Demolish a ca. 1950 house.

ARCHITECTURE

One-story, wing-and-gable plan frame house with synthetic siding; partial-width, shed-roofed independent porch on ornamental metal supports; single 1:1 fenestration.

RESEARCH

The house was built in 1950 by Barney H. and Billie Sue Thames, who lived here until around 1953. Barney Thames had grown up in and around Plainview, Texas, and was a salesman for Paul O. Simms, a local real estate, insurance, and loan broker in Austin. The house was then a rental property until the early 1970s. Tenants included the manager of the Singer Sewing Machine Company, office workers, and a milk man. The house was purchased by Donald and Deborah Grantham in the early 1970s; they lived here until around 1980. Donald Grantham was an installer for the Telephone Company. The house was then a rental property again; in the early 1980s, the house was rented by noted local musician Marcia Ball.

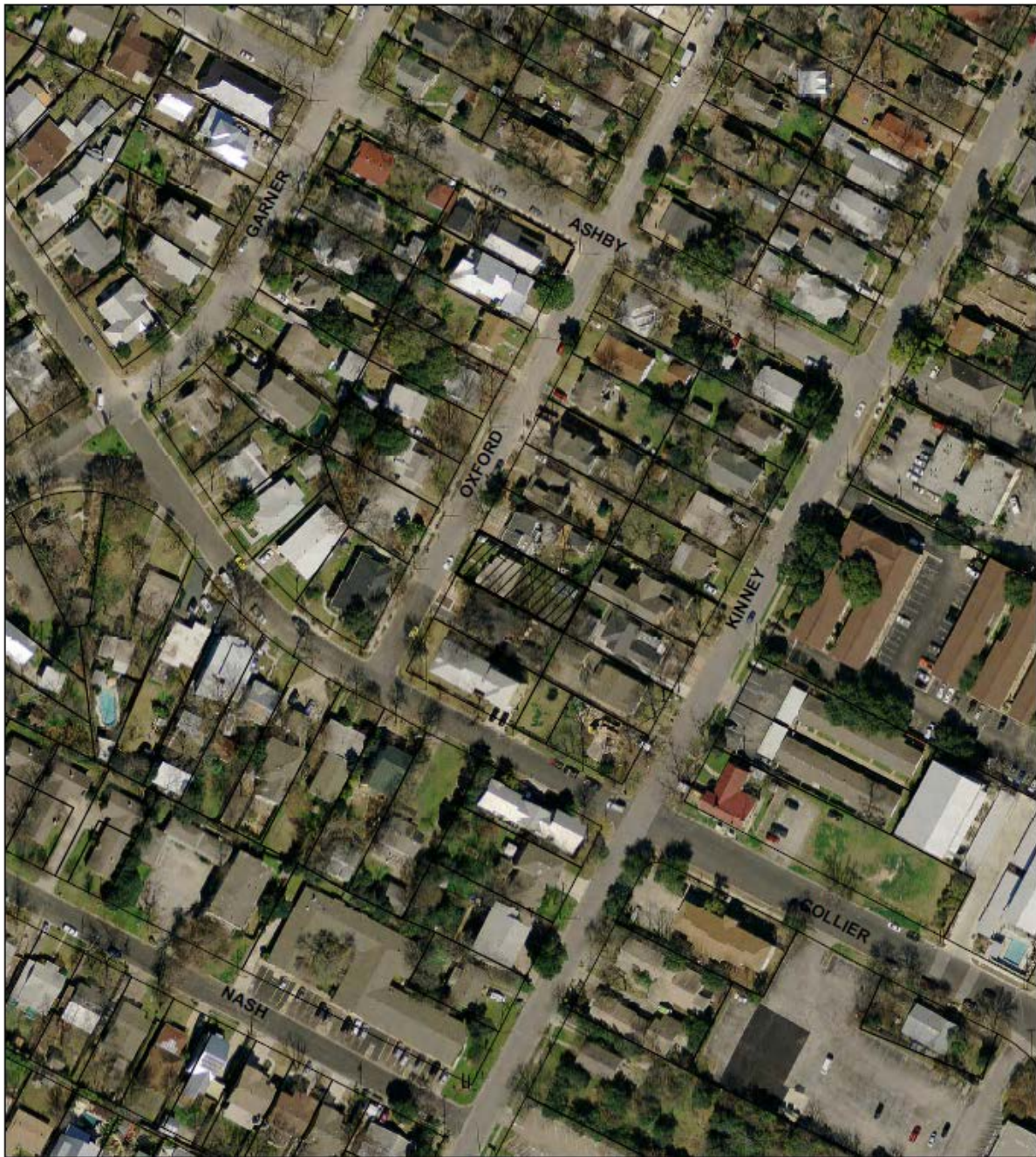
STAFF COMMENTS

The house is beyond the bounds of any City survey.

STAFF RECOMMENDATION

Encourage rehabilitation and adaptive re-use, then relocation over demolition, but release the permit upon completion of a City of Austin Documentation Package, consisting of photographs of all elevations, a dimensioned sketch plan, and a narrative history, for archiving at the Austin History Center. The house is a very good example of post-World War II residential construction and appears to maintain a very high degree of integrity. Moreover, it is of a scale that defines many neighborhoods in South Austin, and careful thought as to whether demolition is truly necessary should be entertained by the applicant.

BIOGRAPHICAL NOTES:

Barney H. and Billie Sue Thames (ca. 1950 – ca. 1953)

Barney H. Thames is listed in the 1940 U.S. Census as the grandson of William H. and Viola Reese of Hale, County, Texas. Barney Thames was born in Texas and had no occupation listed. His grandparents owned their farm in Hale County. The 1930 U.S. Census shows Barney Thames, Jr. as the 9-year old son of Barney and Artie Thames of Plainview, Texas. Barney and Artie Thames owned their home; the elder Barney Thames was a loan and insurance agent.

Billie Sue Thames Nov. 17, 1926 - Aug. 13, 2009

Billie Sue Thames went home to our Lord peacefully on August 13, 2009 at the age of 82. She and her triplet sisters were the youngest of seven daughters born to Minor Cleveland Williams and Claudia Adena Williams. Awaiting her in Heaven are her loving husband, Ret. Col. Barney H. Thames, her eldest son Randle F. Thames, and all of her sisters, Bobbie Lambright (beloved twin sister), Thelma Wendlandt, Bernice Smith Tippit, Dorothy V. Connolly, Betty Jo Lindgren Perry and her infant triplet sister, Emma Williams. She is survived by her daughters, Pamela McCroskery and Barbara Brooks, her son Scott Thames, her grandchildren, Austin and Travis Womble and Sarah, Hannah and Caleb Brooks, as well as numerous nieces and nephews and other family members.
