HISTORIC LANDMARK COMMISSION AUGUST 22, 2016 DEMOLITION AND RELOCATION PERMITS HDP-2016-0482 1617 S. 2ND STREET

PROPOSAL

Demolish a ca. 1911 house.

ARCHITECTURE

One-story, rectangular-plan, hipped-roof, frame cottage with a partial-width inset porch on turned wood posts; many windows have been recently replaced.

RESEARCH

The house appears to have been built around 1911 and was first occupied by Robert H. Davis, a bartender in a beer saloon on S. Congress Avenue. Robert Davis lived here until around 1914, when the house was occupied by a laborer, Lucio Hernandez. A painter, Jesse C. Chaney, is listed as the occupant of the house in the 1916 city directory, and in 1918, it appears that the first African-American family moved into the house. Wiley and Bessie Miller are listed as the renters of the house. Wiley Miller was a laborer. The house was vacant around 1920, then rented (and later owned) by Melvin and Sadie Battle, who lived here until Sadie's death in 1960. Melvin Battle had a number of occupations listed in the city directories, including a farmer, a teamster, a laborer, a yardman, and a cook at the State School for the Deaf. The 1940 U.S. Census shows Melvin Battle as the greens keeper for a golf course, while Sadie Battle was a laundress at home for a private family.

There is some confusion as to whether this is the house that was owned and occupied by Melvin and Sadie Battle. There is a demolition permit in city building records to demolish the house in 1971, but then another in 1974 to remodel and repair the existing house. Another building permit in 1974 indicates that move of a frame house to the site.


STAFF COMMENTS

The house is listed in the Comprehensive Cultural Resources Survey (1984) but without a priority for research.

STAFF RECOMMENDATION

Postpone to September 26, 2016 to fully evaluate alternatives to demolition and to fully understand the history of this house. If this house is the Battle house, then it, as well as the one next door (1615 S. 2^{nd} Street), also up for demolition, reflects the history of the neighborhood as it moved from a lower-income Anglo neighborhood to an African-American neighborhood. Melvin and Sadie Battle, who lived in this house for almost 40 years, represent typical occupations for African-Americans in Austin in the mid-20th century – he worked as a greenskeeper on a golf course, while she did a private family's laundry, and had also been a maid. Aside from the replacement windows, the house is intact, and rehabilitation and restoration of this house is certainly an open option. Staff recommends the postponement for the applicant to consider preservation of this house, if it can be determined that it is the original house on the site, and not the one referenced in the 1974 building permit to move a frame house onto the site. If the Commission votes to release the permit, then staff recommends relocation over demolition, and completion of a City of Austin Documentation Package prior to release of the permit.

BIOGRAPHICAL NOTES

Melvin and Sadie Battle (ca. 1921 – 1960)

The 1920 U.S. Census shows Melvin and Sadie Battle as the renters of a farm house on the Austin-Lockhart Road in Travis County, Texas. Melvin Battle was 34, had been born in Texas, and was a farmer. Sadie Battle was 25, had been born in Texas, and was a farm laborer. With them lived Sadie's mother, Katie White, a 52-year old Texas-born widow who worked as a washerwoman.

Melvin and Sadie Battle appear in the 1930 U.S. Census as the owners of this house, which was worth \$480. Melvin Battle was 39, had been born in Texas to North Carolina-born parents, and was a yard man for a country club. Sadie Battle was 27, had been born in Texas, and was a maid for a private family. They had no children listed with them.

The 1940 U.S. Census shows M.A. and Sadie Battle as the owners of this house, which was worth \$300. M.A. Battle was 55, had been born in Texas, and was the greens keeper for a golf course. Sadie Battle was 46, had been born in Texas, and was a laundress at home for a private family. They had no children listed with them.

Her 1960 death certificate shows that Sadie Lee Battle was born in Travis County to Willie Shite and Katie Sneed White in 1900. She was living in this house at the time of her death. She was a housewife.

Funeral services for Mrs. Sadie Battle, who died Sunday in a local hospital, will be held at Goodwill Baptist Church Thursday at 3 p. m. with Rev. E. B. Brown officiating. Burial will be in Evergreen Cemetery under direction of Fuller Mercer Sheffield Funeral Service. Pallbearers will be Titus Darby, J. L. Prosser, Limuel Franklin, William Bradshaw, Willie King and T. E. Davis.

Survivors include her husband, Melvin Battle of Austin; one sister, Mrs. Roberta Harris of Austin; four nephews and two nieces.


