PROPOSAL

Demolish a ca. 1940 house.

ARCHITECTURE

One-story, rectangular-plan, pyramidal- and hipped-roof brick-veneered house with modern replacement windows in single, double, and triple configurations; recessed entry.

RESEARCH

Murray Graham, a local developer, took out a building and sewer permit for this address in 1939, but apparently, that house was never built. The current house dates from 1940, and was built by C.E. Henderson. It was vacant for a short time after construction, then rented by Rev. Basil and Myrta Shilling until around 1946. The Shillings were from Oklahoma, and Rev. Basil Shilling was the pastor at the University Church of Christ while in Austin. He died in Memphis, Tennessee in 1995. There were a series of owners through the late 1940s and early 1950s, including a director of equalization for the State Department of Education, and a plumbing salesman. In the mid-1950s, the house was rented by a general contractor, then owned by a department manager at Sears in the late 1950s. A series of renters followed until the mid-1980s, when the house was owned and occupied by John D. English, a trade show and convention coordinator for the Texas Manufactured Housing Association.

STAFF COMMENTS

The house is beyond the bounds of any City survey. The house is listed as non-contributing to the Old West Austin National Register Historic District.

STAFF RECOMMENDATION

Release the permit upon the review of plans for the replacement structure by the Commission. This house has neither the architectural nor the historical significance to warrant individual designation as a historic landmark.

BIOGRAPHICAL NOTES:

Basil and Myrta Shilling (ca. 1942 – ca. 1946)

The 1940 U.S. Census shows Basil and Myrta Shilling as the renters of the house at 301 Moore Boulevard in Austin. Basil Shilling was 40, had been born in Oklahoma, and was a minister. Myrta Shilling was 42, had been born in Oklahoma, and had no occupation listed. They had a daughter, Tommy J., 13, who had been born in Oklahoma. The family had lived in Healdton, Oklahoma in 1935. Basil Shilling died in Memphis, Tennessee in 1995. He was a gospel preacher.
