PROPOSAL

Demolish a house that was moved onto the lot from an unknown location ca. 1972.

ARCHITECTURE

One-story, rectangular-plan, hipped-roof frame house with a prominent front-gabled independent porch; single and paired 1:1 fenestration – mostly replacement windows.

RESEARCH

The house was moved onto the current site in 1972 from an unknown location. Here on Lyons Road, the house was occupied and owned by Arthur and Josie Castro. Arthur Castro was a laborer at Calcasieu Lumber Company when they first moved into this house; he then worked for Barker's Office Furniture in the early 1980s, and was a contractor in the late 1980s and early 1990s.

STAFF COMMENTS

The house is beyond the bounds of any City survey to date.

STAFF RECOMMENDATION

Encourage relocation over demolition, but release the permit. The house was moved onto the site in 1972 and has been modified to an extent that it no longer conveys much of its historic architecture.
