Skills and Experience: My passion for pedestrian safety comes from many years living in walkable cities both large and small, including Taipei, New York, Washington, D.C., and Charlottesville. I also have some practical skills that I believe would be useful to the PAC. I have experience as a commercial real estate developer working on mixed-use projects in walkable, urban markets. In that role, I have made it a top priority to implement the highest standards of pedestrian and bike oriented design in my projects. Also, in my experience as an investment professional, including time as an investment banker, I have helped raise almost \$10 billion in capital for projects. I believe my time working with architects, engineers and users on the design of projects and my experience working with capital sources on their financing would allow me to provide valuable input in the creation and implementation of the PAC's projects and priorities.

==Your Interest in the PAC==

Why do you want to serve on the Pedestrian Advisory Council? :

All Austin residents, regardless of age or ability, should have access to safe, contiguous pedestrian routes around town.

Walkable neighborhoods are safe and resilient, and they provide residents with greater health, environmental and economic benefits than car-dependent neighborhoods. As a former Captain in

the Marine Corps, serving and protecting the public is very important to me. Last year, 32 of the 102 fatalities on Austin roads were either pedestrians or bicyclists. In my opinion, none of these deaths are acceptable collateral damage for allowing the rest of Austin's residents to save time in their commutes via high speed limits and poor road design.

The lives of Austin's residents are the city's most valuable resource. We must bring all resources to bear and take immediate action to bring pedestrian deaths as close to zero as possible. Improving road design (narrowing lanes, building pedestrian refuges, adding sidewalks on every street), changing road rules (lowering speed limits, eliminating rights on red in pedestrian zones, etc.), and improving enforcement activities (citing dangerous drivers in pedestrian zones) are some available tools at our disposal. Some changes are low/no cost and others require big investments. Regardless, all options should seem cheap and easy compared to the unacceptable loss of life we see every year in this city.

The Pedestrian Advisory Council can do a lot to both save and improve the lives of Austin's residents. I would like to do everything I can to support that mission, and it would be a great honor to serve on the PAC. Thank you for your consideration.
