## PROPOSAL

Demolish a ca. 1952 house.

#### ARCHITECTURE

One-story, rectangular-plan, mansard- and flat-roofed frame house with single 1:1 and fixed-sash fenestration; partial-width flat-roofed wraparound porch.

## RESEARCH


The house was built in 1952; the first owners and occupants were Marvin and June Self, who lived here until around 1963. Marvin Self was a salesman at Montgomery Ward; June Self worked in the diamond department at Kruger's Jewelry. They later moved to the Houston area. From around 1963 to around 1970, the house was owned and occupied by Rupert and Clara Strawn. Rupert Strawn was a pharmacist. The house was a rental property after that.

## STAFF COMMENTS

The house is beyond the bounds of any City survey.

## STAFF RECOMMENDATION

Release the permit. The house has been substantially modified since the time of its original construction, and lacks the requisite historical and architectural significance for designation as a historic landmark.

## **BIOGRAPHICAL NOTES**

## Marvin C. and June Self (ca. 1952 - ca. 1963)

Marvin Self, Jr. appears in the 1940 U.S. Census as the 17-year old son of Marvin and Edith Self, who rented their house at 3807 Duval Street in Austin. Marvin Self, Jr. was born in Texas and had no occupation listed. His father was a Texas-born insurance checker. His mother had no occupation listed. Marvin, Jr.'s older sister, Louise, 21, was a typist for a department store. The family had lived in Waco in 1935.

Cora June Self died in Harris County in 1982. Her death certificate shows that she was living in Spring, Texas at the time of her death. She had been born in Ohio in 1920 and was a diamond department manager for a jewelry store. She died from a crushed chest suffered in a motor vehicle accident. Marvin V. "Bub" Self, Jr. died in Houston in 2003.

## Rupert and Clara Strawn (ca. 1963 – ca. 1970)

Rupert Strawn's 1973 death certificate shows that he was living in Burnet, Texas at the time of his death. He was born in Greenville, Texas in 1904 and was a pharmacist.
