#### Analysis: Three Major Categories


- 1. "Priority" issues identified by the Texas Legislature as critical.
- 2. "Oppose" the City will work to defeat any bill that contradicts or undermines specific position(s) adopted by the City Council.
- **3.** "Support" the City isn't initiating the ask but will support and work it if someone else files it. Includes support of bills that contribute to the achievement of position(s) adopted by the City of Austin and will positively impact operations.
- ✓ You do not have to articulate every single "defense" statement but you do want to articulate those policy areas that are most important. Same sentiment with your "support" category.


✓ Focus on municipal issues.

### "Priority" Issues

"Priority" during a legislative session is determined by:

- The Texas Legislature: Leadership and members
- Interim charges
  - Issues highlighted during Interim Hearings
  - Issues Legislators have highlighted in public comments





# THE LOBBY TEAM

### **Review of Lobby Team**

- Catalog of knowledge regarding municipal and City of Austin issues.
- Review of clients: (1) conflicts; (2) experience and capacity.
- Analysis regarding work relationships in current political climate.
- Review of history with the City including analysis of whether the reason/need for their hire still exists.
- Discussions and evaluations with City departments regarding their experience with the lobbyists.

#### **Recommended Qualifications for Lobby Team**

- Expertise with municipal issues, particularly:
  - Public utilities
  - Land development, municipal regulation
  - Strategic recommendations
  - Transportation (federal)
- Relationships with leadership and delegation:
  - House and Senate
  - Governor's office
  - Key committee leadership
  - Key agencies: TCEQ, PUC, Comptroller, GLO, & TDHCA
