Authorize award and execution of a 12-month contract with VWR INTERNATIONAL LLC, to provide laboratory chemicals and supplies in an amount not to exceed \$435,923, with five 12-month extension options in an amount not to exceed \$505,837 per extension option, for a total contract amount not to exceed \$2,965,108.					
Amount and Source of Funding					
Funding in the amount of \$399,596 is available in the Fiscal Year 2016-2017 Operating Budget of Austin Water. Funding for the remaining month and extension options are contingent upon available funding in future budgets.					
Fiscal Note					
A fiscal note is not required.					
Purchasing Language:	The Purchasing Office issued an Invitation for Bids (IFB) JXP0118 for these goods on August 8, 2016 and it closed on August 23, 2016 with four offers received. The recommended offer is the lowest offer submitted by a responsible offeror. Additional information on the solicitation is included below the line. The recommended offeror is the current provider for these goods.

MBE / WBE:	This solicitation was reviewed for subcontracting opportunities in accordance with City Code Chapter 2-9D Minority Owned and Women Owned Business Enterprise Procurement Program. For the goods required for this solicitation, there were insufficient subcontracting opportunities and an insufficient number of certified M/WBEs; therefore, no subcontracting goals were established.				

### Additional Backup Information

The contract will provide laboratory chemicals and supplies for the Laboratory Services Division of Austin Water. The laboratory chemicals and supplies used must meet standards prescribed by the Environmental Protection Agency (EPA) and Texas Commission on Environmental Quality (TCEQ) approved testing methodology. The laboratory tests water quality of, drinking water, raw surface water, wastewater, bio-solids, industrial waste samples, treatment chemical samples, and other environmental water samples.

If the City does not execute this contract, the City will have to purchase chemicals and supplies on the open market at potentially higher costs.
