PROPOSAL

Demolish a ca. 1883 house.

ARCHITECTURE

One-story, wing-and-gable plan, frame house with synthetic siding, some replacement windows, and a partial-width, shed-roofed independent porch.

RESEARCH

The house appears to have been built around 1883 by Andrew Sanders, a Swedish immigrant who worked as a car inspector and repairman for the Houston and Texas Central Railroad. His daughter, Esther, married August Gustafson; they moved into this house and Andrew Sanders and his wife moved into a house next door. August Gustafson was first listed as a laborer, then a pipefitter, and then went to work as a car repairman for the International and Great Northern Railroad around 1913. He and Esther lived in this house until the early 1950s, when they both passed away.

The house was then purchased by Robert and Margaret Moreno, who lived here for the rest of their lives. Robert Moreno was a cook at the Pik-Nik Grill on the north end of the Drag. He is not listed in the city directories after the early 1970s, but both his and Margaret's obituaries reference their marriage until their deaths. Margaret Moreno was a child and family services aide and social worker.

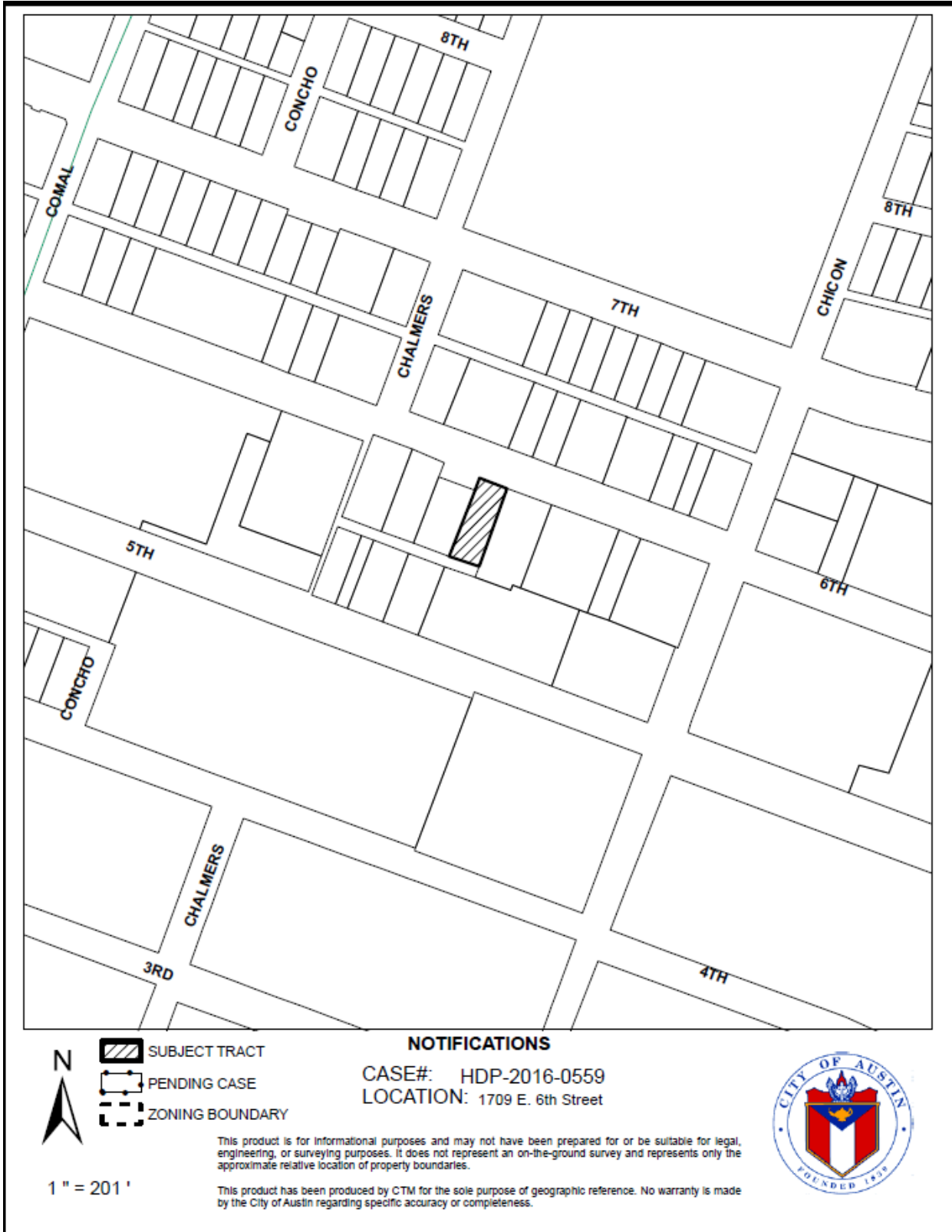
STAFF COMMENTS




The house is listed in the East Austin Historic Survey (1980); the survey photograph shows wood siding, wood windows, and a Palladian window in the tympanum of the front gable.

STAFF RECOMMENDATION

Encourage rehabilitation and adaptive re-use, then relocation over demolition, and strongly encourage the applicant to continue to fully evaluate alternatives to demolition, but release the permit upon completion of a City of Austin Documentation Package, consisting of photographs of all elevations, a dimensioned sketch plan, and a narrative history, for archiving at the Austin History Center.

BIOGRAPHICAL NOTES

Andrew A. Sanders (ca. 1883 – ca. 1910)

The 1900 U.S. Census lists an Edward [Andrew] Sanders at this house, which is addressed as 1809 E. 6th Street. He was 52 years old, had been born in Sweden, and had immigrated to the United States in 1870. He listed his occupation as a car inspector. His wife, Christine [Ida], was 42, had been born in Sweden, and immigrated to the United States in 1875. They had four children: Beda, 19, Wesley, 16, Henning, 15, and Esther, 18. Esther Sanders married August Gustafson and continued to live in this house after her marriage.

The 1920 U.S. Census shows Andrew A. and Ida C. Sanders as the owners of the house at 1809 E. 6th Street in Austin, which would have been next door, as August and Esther Gustafson were living in this house at the time of the census report. Andrew A. Sanders was 73, had been born in Sweden, and immigrated to the United States in 1875. He became a naturalized citizen in 1888. He had no occupation listed. Ida C. Sanders was 68, had been born in Sweden, and immigrated to the United States in 1875, and had no occupation listed. They had a son, Henning A., 33, who had been born in Texas, and worked as a flower gardener at the cemetery.

The 1930 U.S. Census shows Ida C. Sanders as the owner of the house next door at 1809 E. 6th Street, which was worth \$1,700. She was a 71-year old Swedish-born widow with no occupation listed. She had roomers: James and Connie Dounain. James Dounain was 32, had been born in Texas, and was a switchman in the train yard. Connie Dounain was 19, had been born in Texas, and had no occupation listed.

A. A. SANDERS

A. A. Sanders, aged 80, passed away at his home, 1809 East Sixth street, Saturday evening after a long illness. He is survived by his wife, two daughters, Mrs. Beda Frederickson, of Georgetown, and Mrs. Esther Gustafson, of Austin; one son, Henry Sanders, of Austin, and four grandchildren. Funeral services will be held Monday afternoon, 3:30 o'clock, from the residence and 4 o'clock at the Swedish Methodist church, with the Rev. Oscar E. Linstrum, officiating. Interment will be in Oakwood cemetery.

August and Esther Gustafson (ca. 1908 – ca. 1953)

The 1910 U.S. Census shows the house addressed as 1809 E. 6th Street occupied by August Gustafson, 25, his wife Esther, 22, and son Arthur, 1. August Gustafson had been born in Sweden and worked as a car repairer for the railroad company. Esther Gustafson had been born in Texas, as had their son. Esther Gustafson had no occupation listed. Andrew A. and Ida Sanders are not listed in this census report.

The 1920 U.S. Census shows August G. and Esther A. Gustafson as the owners of this house, which is addressed as 1811 E. 6th Street. August Gustafson was 36, had been born in Sweden, and had immigrated to the United States in 1905. He became a naturalized citizen in 1910. He was a car repairer for the railroad. Esther A. Gustafson was 32, had been born in Texas, and had no occupation listed. They had 3 sons: Arthur G., 10; Oscar W., 6; and Clifford E., 2.

The 1930 U.S. Census shows August and Esta Gustafson as the owners of the house addressed as 1811 E. 6th Street; the house was worth \$2,000. August Gustafson was 46, had been born in Sweden, and was a car inspector for the railroad. Esta Gustafson was 42, had been born in Texas, and had no occupation listed. They had 3 sons living with them: Oscar, 17; Clifford, 12; and Wullas [?], 7. All of the boys had been born in Texas, and none had an occupation shown.

Her 1951 death certificate shows that Esther Gustafson was the daughter of A.A. and Ida Sanders. She was living at this house at the time of her death. She was born in 1888 in Texas, and was a housewife.

His 1953 death certificate shows that August Gustafson was living at this house at the time of his death. He had been born in Sweden in 1883 and was a widower. He was a repairman for the railroad.

Robert and Margaret Moreno appear in the 1940 U.S. Census as the renters of the house at 1209 Inks Avenue. Robert Moreno was 25, had been born in Texas, and was a cook in a cafe. Margaret Moreno was 23, had been born in Texas, and had no occupation listed. They had 3 children: Robert, Jr., 4; Rebecca, 3; and Rachel, 1. All the children had been born in Texas.

The 1930 U.S. Census shows Robert Moreno as the 16-year old son of Frank and Mary Moreno, who lived at 806 East Avenue in Austin. Robert was the 3rd of the couple's 9 children. He had been born in Texas and was a clerk in a grocery store. His parents had both been born in Texas. His father was a waiter in a café; his mother had no occupation listed.

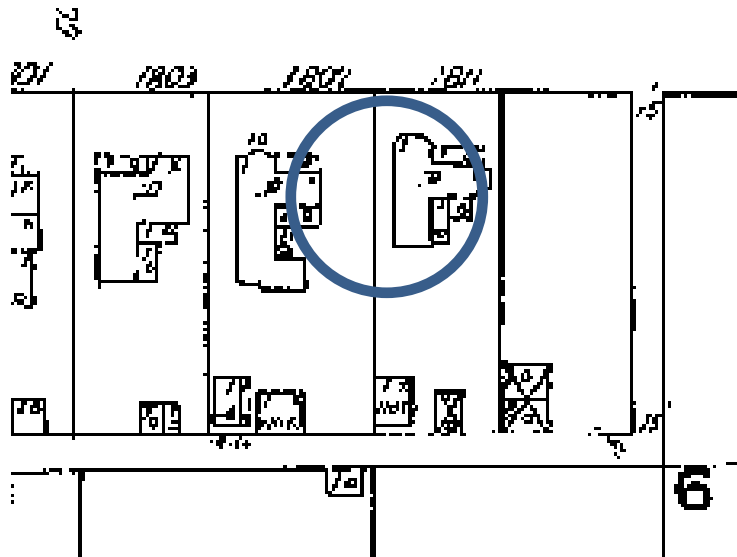

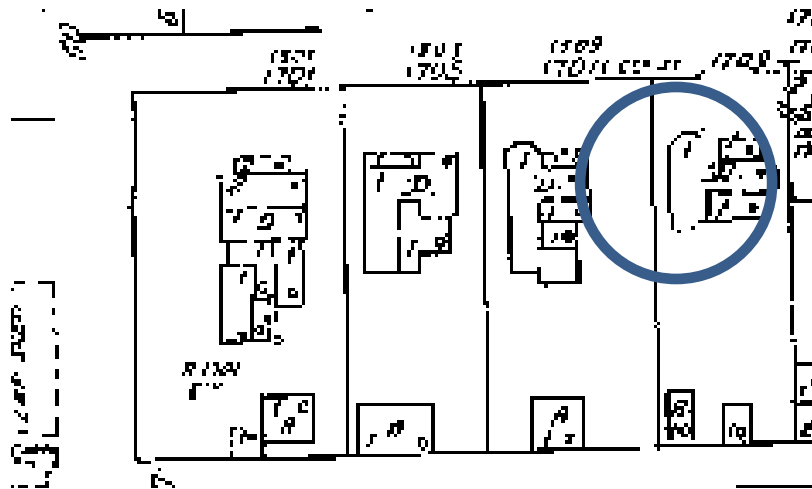
