The Council accepts and approves the returns for the special election, as tabulated and received and canvassed, and declares that Proposition No. 1 is adopted.

The Council finds that the results of the general election as tabulated and canvassed reflect the votes cast at the election; and

The Council accepts and approves the returns for the general election, as tabulated and received and canvassed, and declares that the following persons are declared elected and may qualify for the office indicated for terms that begin January 6, 2017:

City Council Member District 2 Delia Garza

City Council Member District 4 Gregorio "Greg" Casar

City Council Member District 6 James "Jimmy" Flannigan

City Council Member District 7 Leslie Pool; and

In order to elect a City Council Member for District 10 the City Council shall order a runoff election as soon as is practicable and no later than the fifth day after this canvass as required by state law (Texas Election Code § 2.024).
