**AN ORDINANCE SETTING THE COUNCIL MEETING SCHEDULE FOR

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:


PART 2. Section 2-5-24(A) of the City Code is waived to the extent of any conflict.


