

ORDENANZA No. 20161122-002

ORDENANZA PARA CONVOCAR UNA ELECCIÓN SECUNDARIA QUE SE EFECTÚE EN LA CIUDAD DE AUSTIN EL 13 DE DICIEMBRE, 2016, CON EL PROPÓSITO DE ELEGIR AL CONCEJAL DEL DISTRITO 10 DE LA CIUDAD; DISPONIENDO PROVISIONES PARA QUE SE EFECTÚE LA ELECCIÓN; Y PARA DECLARAR QUE HAY UNA EMERGENCIA.

POR ORDEN DEL CONSEJO DE LA CIUDAD DE AUSTIN:

PARTE 1. Que se efectúe una elección secundaria municipal en la Ciudad de Austin el 13 de diciembre, 2016 de acuerdo con disposiciones del Artículo II y el Artículo III de la Carta de la Ciudad de Austin, y de las leyes del Estado de Texas. En dicha elección los votantes capacitados del Distrito 10 elegirán al Concejal del Distrito 10. Los candidatos para el puesto del Distrito 10 cumplirán todos los requisitos y serán residentes del Distrito 10, y será electo por la mayoría del voto de votantes residentes en el Distrito 10.

PARTE 2. La elección se efectuará durante las horas de las 7:00 a. m. a las 7:00 p.m. Los precintos y sitios de la votación el día de la elección; las fechas, horas, y ubicaciones de los sitios de la votación adelantada; y los nombres de los oficiales nombrados para efectuar la elección se indican en los Adjuntos A-E adjuntados e incorporados como parte de esta ordenanza.

PARTE 3. Un "sistema electrónico de votación directa" de acuerdo con el término definido en el Título 8 del Código Electoral de Texas; se usará en la votación adelantada y en la votación efectuada el día de elección. La Estación Central Para Contar Votos se ubicará en la División de Elecciones del Condado Travis en 5501 Airport Boulevard, Austin, Texas.

PARTE 4. El aviso de esta elección se hará fijando y publicando una copia de esta Ordenanza en ambos idiomas, inglés y español. El aviso y una copia de esta ordenanza se fijarán, en ambos idiomas, inglés y español en la oficina de la Secretaria de la Ciudad y en el kiosco de avisos en el Edificio Municipal (City Hall), a no más tardar del 15vo día antes del día de la elección. El aviso de esta elección será publicado una vez, en fecha que no sea anterior del 30vo día de la fecha de la elección ni más tardar del 10mo día antes de la fecha de la elección, en un periódico de circulación general en la Ciudad de Austin.

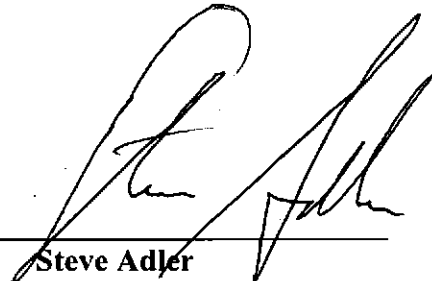
PARTE 5. Los candidatos electos el 8 de noviembre, 2016, en la elección general y el 13 de diciembre, 2016, en la elección secundaria, tomarán el juramento del puesto y principiarán sus plazos en el puesto el 6 de enero, 2017.

PARTE 6. El Consejo determina, que por ser corto el tiempo para efectuar la elección secundaria, y como el Consejo desea dar oportunidad para el voto adelantado, hay la necesidad de iniciar inmediatamente los preparativos requeridos para esta elección. Dicha necesidad constituye una emergencia, y el Consejo declara que existe la emergencia. Por razón de esta emergencia, esta ordenanza tendrá vigor inmediatamente al aprobarse para la conservación inmediata del orden público, la salud, seguridad, y bienestar en general.

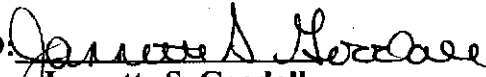

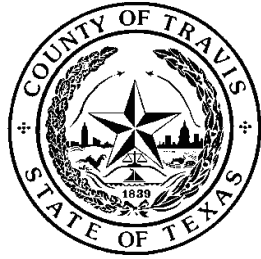
