

## M/WBE Summary

Public notice was given for this solicitation, CLMC613, Gus Garcia District Park Phase 3 Improvements project, through the City's Vendor Connection web portal which resulted in 1,272 contractors receiving notification and 82 contractors obtaining bid documents. Five bids were received and opened on November 8, 2016. One of five bids received was from a certified MBE/WBE firm. Smith Contracting Co, Inc. submitted the lowest responsive bid:
