Old West Austin

PROPOSAL

Modify the existing front-gabled dormers to shed-roofed dormers with triple windows, and replace existing front windows.

PROJECT SPECIFICATIONS

The applicant proposes to remove the existing front-gabled dormers and replace them with shed-roofed dormers across the front roof of the house; each dormer will have three windows. The applicant further proposes to replace all of the existing front windows on the house.

STANDARDS FOR REVIEW

The Old West Austin National Register Historic District has no design guidelines for modifications to contributing structures, but general design principles in historic district encourage retaining the original features on the front of the house. Appropriate materials for the replacement windows on a contributing structure are replacement in kind, or with a material that approximates the appearance and profile of the existing windows.


STAFF COMMENTS

It is not clear whether these dormers are original to the house; they do not appear to be in keeping with the scale and symmetry of the house. The proposed dormer design is not out of character with the Colonial Revival style of the house.

The house, built in 1938, was owned and occupied by a typewriter salesman, a Highway Department engineer, and most recently, by a real estate agent. While contributing to the historic district, it does not appear to qualify as a historic landmark.

STAFF RECOMMENDATION

Release the permit as proposed for the dormers, and request that the applicant consider retaining and rehabilitating the existing windows, but also request the completion of a City of Austin Documentation Package, consisting of photographs of all elevations, a dimensioned sketch plan, and a narrative history, for archiving at the Austin History Center, prior to release of the permits.







BIOGRAPHICAL NOTES

Price and Pearl Pincham (ca. 1937 – ca. 1943)

The 1930 U.S. Census shows Price C. and Pearl Pincham as the renters of the house at 201 E. 35th Street in Austin. Price C. Pincham was 34, had been born in Texas, and was a typewriter salesman. Pearl Pincham was 34, had been born in Texas, and had no occupation listed. They had no children listed with them.

Price Campbell Pincham died in Dallas in 1958. His death certificate notes that he had been living in Dallas for the 9 years prior to his death. He was married to Pearl Pincham, and had been born in 1895 in Texas. He was the owner of an office equipment company.

George A. and Elizabeth Weisser (ca. 1946 – ca. 1959)

City directories from Fort Worth, Texas show that George A. Weisser lived in Fort Worth in the 1940s before moving to Austin, and returned to Fort Worth in the 1960s after living in Austin. The 1968 Fort Worth city directory shows George A. and Elizabeth B. Weisser living there; he was a civil engineer for the Federal Highway Administration.

The 1930 U.S. Census shows George A. Weisser as the 19-year old son of M. Frank and Bertha R. Weisser, who owned their home in Oakdale, Washita County, Oklahoma. George A. Weisser had been born in Kansas, and had no occupation listed. His father, who had been born in Kansas, was a farmer. George was the older of the couple's two children listed. His younger brother, Bert, 17, had been born in Kansas and had no occupation listed.

George A. Weisser died in 2010 in Mountain View, Kiowa County, Oklahoma.

George A. Weiser

George Albert Weisser of Mountain View, OK passed away December 13th, 2010 at the Carnegie Hospital. He was three months shy of his 100th birthday. George was born in Valencia, KS on March 11th, 1911 to Martin Frank (Bud) Weisser and Bertha Ruth Jones. They moved to Oklahoma and George and his brother Bert grew up on a farm five miles northeast of their current farm home. George attended the Silver Moon grade school that is currently a storage barn on the current farm. George attended Carnegie High School and got an engineering degree from the University of Oklahoma in Norman, OK. He went to work at the Bureau of Public Roads in Fort Worth, TX as a civil engineer, where he met his future wife, Violet Elizabeth (Betty) Barnett. They married on October 16, 1938. George entered the military just prior to WWII and trained in artillery at Fort Sill. After a period in an artillery Unit in the South Pacific (New Caledonia), he transferred to the Signal Corps and sent and received coded messages for the South Pacific Command Center. He continued as a U.S. Reserve LTC. After the war George and Betty started a family in 1947 with the birth of their oldest son Frank, who currently lives in Houston. Their second son Carl was born in 1950, and has resided with George since 2003 at the farm. In 1972 George retired and they moved to the farm where they built a new house and joined the First United Methodist Church of Mountain View, OK. George did not retire from farming until he was about 85 years old, and continued to have his finger in the farm operations almost up to his death on Monday.

Survivors include two sons, Frank Weisser of Houston, TX and Carl Weisser of Mountain View, OK; granddaughter, Lee of Boston, MA; grandson, Ross of Houston, TX; and two great grandchildren, Victoria and Andrew.


He was preceded in death by his parents, his wife Betty, and his brother Bert.

However, Richard's older brother, Gregory, 22, had been born in Wisconsin.

Richard H. (Dick) Einck of Austin died at home on Tuesday, at the age of 64, after a lengthly illness.

Mr. Einck moved to Austin from Iowa in 1945, after having recieved an honorable discharge with the rank of Chief Petty Officer for his service aboard the U.S.S. Weaver, D.E., in the Pacific Naval Theatre during World War II.

Mr. Einck was well known and liked in Austin, having started his business career as vice-president of Leo M. Black Motors, selling Studebakers and Packards for several years.

Over the years he served on many boards and committees for the Austin Board of Realtors. He worked his way up from secretary of the Board of Realtors to become one of their Board of Directors, and Chairman of the Court of Ethics and Arbitration for many years.

Because of his dedication and professionalism, he was awarded both the Distinguished Salesman's Award by the Sales and Marketing Executives Club of Austin, and the Salesman of the Year Award by the Austin Board of Realtors in 1973.

Through the years Mr. Einck was very active in many civic clubs and organizations. He served as president of the Capital City Kiwanis Club. He was an active supporter and member of the Austin Chamber of Commerce and the Austin Aqua Festival. He was also a member of the distinguished President's Club, and recieved a lifetime membership from the Chamber for his many years of service and good will.

As a member of the Knights of Columbus, he served on their Board of Directors and was an active member of St. Austin's Catholic Church and Ushers Club.

Due to failing health, Mr. Einck retired from his business, Dick Einck Realty. Upon retirement, he was awarded the Realtor Emeritus status by the Austin Board of Realtors, His son is carrying on the family business.
