PROPOSAL

Demolish a ca. 1939 house.

ARCHITECTURE

One-story, cross-gabled brick-veneered house with single and paired 1:1 fenestration; wood shingles in the tympanum of the front-facing gable. The brick veneer was added to the house in 1959.

RESEARCH

The house was built in 1939 by Earl and Homerzelle Swisher, who lived here until around 1943. Earl Swisher was a public school teacher. He and Homerzelle eventually moved to the San Francisco Bay area of California, where they passed away.

In the mid-1940s, the house was rented by Thomas and Ruth Mayes. Thomas Mayes was a native of Hempstead, Texas, and graduated from Prairie View A&M College with a degree in agriculture. He became the Negro Extension Agent for the Texas Agricultural Extension Service around 1940, and in this capacity, he was instrumental in bringing new innovations in agriculture to African-American farmers in Travis County. He also helped African-American farmers secure loans and maintain both their farms and their credit. He was a strong supporter of 4-H Clubs for African-American children, and worked diligently to help his constituents win awards for their agricultural projects. He worked closely with Opal Washington in the Negro Extension Office; her home on E. 7th Street is also a city historic landmark, as is the site of the Negro Extension Office on Lydia Street. By all accounts, Thomas Mayes was exemplary, influential, and inspiring to a large number of African-American farm families in Travis County in his 30-year career. Ruth Banks was also active in the African-American community in Austin; she was a public school teacher at Blackshear Elementary.

From the late 1940s until around 1960, the house was the home of Walter and Phoebe Banks. Walter Banks was a school teacher. From the early 1960s until the mid-1980s, the house was owned and occupied by Emory and Kathy Williams. Emory Williams was a warehouseman for Frostex Frozen Foods.

STAFF COMMENTS




The house is listed in the Comprehensive Cultural Resources Survey (1984) but without a priority for research.

STAFF RECOMMENDATION

Encourage rehabilitation and adaptive re-use, then relocation over demolition, but release the permit upon completion of a City of Austin Documentation Package, consisting of photographs of all elevations, a dimensioned sketch plan, and a narrative history, for archiving at the Austin History Center, and the erection of a marker on the site commemorating the contributions of the residents, particularly Thomas Mayes, to the cultural history of the city.

BIOGRAPHICAL NOTES:

Earl and Homerzelle Swisher (ca. 1939 – ca. 1943)

The 1940 U.S. Census shows Earl and Homerzell Swisher as the owners of this house, which was worth \$1,900. Earl Swisher was 25, had been born in Texas, and was a public school teacher. Homerzelle Swisher was 23, had been born in Texas, and had no occupation listed. They had 2 children: Earline, 23; and Homerzelle, 1. Homerzelle's mother, Lula Cash, a 56-year old Texas-born widow, also lived in the house. She had no occupation listed.

Earl Swisher died in Alameda County, California in August, 1958. Homerzell Cash Swisher died in Alameda County, California in January, 1985.

Mrs. Ruth M. Mayes, of Austin, 83, passed away Monday, August 14, 1989.

Mrs. Mayes was born in Littig, Texas, where she attended public schools. She completed her high school education at Tillotson College in Austin, received her BA degree in education from Wiley College in Marshall, Texas, and her MA degree in remedial reading from Southern California University. Mrs. Mayes was a dedicated teacher in the Littig, Lockhart, and Austin school districts for a total of 44 years.

Mrs. Mayes leaves to cherish her memory her husband of 55 years, Thomas A. Mayes; sister, Mrs. Johnnie Humphrey of Austin; daughter, Mrs. Tommie Mitchell; grandchildren, Mrs. Shawneequa Harris of San Antonio, Mrs. Scheherazade Perkins of Houston, Luther Mitchell, Jr. of Waco; four great-grandchildren; and many nieces, nephews, relatives and friends.

Funeral services will be held on Friday, August 18, 1989, at 12:00 Noon, at Wesley United Methodist Church, Austin.

Services for Thomas Mayes, extension agent, are Saturday

Services will be Saturday for Thomas Mayes, who helped area farmers and taught countless rural children during his 39-year career as an agricultural extension agent. Mayes, 89, died Monday from complications of a fall, his family said.

Mayes, who also owned property and businesses in Austin, was given a humanitarian award in 1985 in recognition of his work at what was then the Negro Chamber of Commerce.

"Mayes leaves a legacy of ambition and community concern, as well as business accomplishments," said Thaddeus McDonald, who worked with Mayes at the Texas Agricultural Extension Service. "I admired his wit and his humor and his ambition and his ability to inspire young people."

Mayes was born and raised in Hempstead. He graduated from

Prairie View A&M University in 1932 with a degree in agriculture. He taught school for one year before beginning his career with the Texas Agricultural Extension Service.

For most of Mayes' career, the extension service was segregated, and his job was to help black farmers and their families. He was a strong supporter of 4-H Clubs and worked to make sure his club members won regional and state awards for their projects and livestock.

Opal Washington, who worked

with Mayes at the extension service for many years, recalled how he chafed at the second-rate treatment the extension service sometimes gave its black agents. But she said Mayes never let discrimination prevent him from helping any farm family.

"One of the things the farmers most appreciated about him is that he had the know-how to help them secure loans and to pay them back," Washington said.

Mayes retired from the extension service in 1970.

Survivors include his wife, Blandie Marie Fitch Mayes; two daughters, Tommye Mitchell of Waco and Dorish Shaheed of La Verne, Calif.; and a stepdaughter, Sandra McIntyre of St. Louis, Mo.

A wake will be at 7 p.m. today at King-Tears Mortuary, 1300 E. 12th St. Services will be at 11 a.m. Saturday at Wesley United Methodist Church, 1160 San Bernard St. Burial will be at Evergreen Cemetery.

Emory Williams (ca. 1960 – ca. 1981)

His 1917 World War I draft registration card shows that Emory K.L. Williams was born in Buda, Texas in 1893, and was living in Austin at the time of his registration. He was a laborer, who had a wife and 2 children. He was of medium height with a stout build, and had black hair and black eyes. ?? Is this the father?

The 1940 U.S. Census shows Emory Williams, Jr., as the 24-year old son of Emory and Maude Williams, who owned their home at 709 W. Mary Street in Austin. Emory Williams, Jr. had been born in Texas and was a truck driver for a wholesale produce company. He was the 2nd of the couple's 8 children. Emory Williams, Sr. was 46, had been born in Texas, and was a laborer. Maude Williams, 44, had been born in Texas, and was a servant for a private family. All of the children in the family over the age of 18 were employed at various jobs including a yardman, a servant for a private family, and a car greaser at a service station.
