### HISTORIC LANDMARK COMMISSION DECEMBER 19, 2016 DEMOLITION AND RELOCATION PERMITS HDP-2016-0873 608 KINNEY AVENUE

### PROPOSAL

Demolish a ca. 1930 house.

### ARCHITECTURE

One-story, rectangular-plan, side-gabled frame house with a shed-roofed overdoor hood; single and paired 1:1 fenestration with a replacement multi-light metal-framed window in the front facade to the right of the entry; synthetic siding; exterior stone chimney.

### RESEARCH

The house was built around 1930 by Dr. Charles Dexter Kinney, a chiropractor and his chiropractor wife and partner, Norma. After Norma passed away in 1936, Dr. C.D. Kinney continued to live here until around 1938. He was listed as a lodger in the home of another in the 1940 U.S. Census and he passed away in 1942.


The house was a rental property in the late 1930s, then purchased by W. Roy and Maxine Ray, who lived here until around 1948. W. Roy Ray was the credit manager for a wholesale auto accessories business in Austin while he and Maxine lived in this house. A secondary unit was constructed in the late 1940s and rented out. The main house was rented, then owned by Lewis and Addie LaBorde, who lived here until around 1980. Lewis LaBorde was from Louisiana, and operated a saw repair shop in Austin. After Lewis died in 1956, Addie continued to live here. She was a telephone operator at the Scottish Rite Dormitory at the University of Texas. She died in Shreveport, La. in 1982.

### STAFF COMMENTS

The house is beyond the bounds of any City survey to date.

### STAFF RECOMMENDATION

Encourage rehabilitation and adaptive re-use, then relocation over demolition, but release the permit upon completion of a City of Austin Documentation Package, consisting of photographs of all elevations, a dimensioned sketch plan, and a narrative history, for archiving at the Austin History Center.

### Charles D. and Norma Kinney (ca. 1930 – ca. 1938)

The 1920 U.S. Census shows Dr. Charles D. and Norma Kinney living in a house they rented at 1328 W. 6<sup>th</sup> Street in Austin. Charles D. Kinney was 50, had been born in Texas, and was a chiropractor. Norma Kinney was 49, had been born in Missouri, and was a chiropractor. With them lived their nephew, Fred Sublette, 14, who had been born in Missouri and had no occupation listed.

Charles and The 1930 U.S. Census shows Charles D. and Mabel Kinney living in a house they owned on Route 5 of Austin. Charles D. Kinney was a 68-year old Texas-born doctor. Mabel Kinney was 59, had been born in Missouri, and had no occupation listed. Fred Sublette is not listed with them.

The 1940 U.S. Census shows Charles D. Kinney as a divorced lodger in the home of T.H. and Clara C. Coulter, who rented a house at 203 W. 7<sup>th</sup> Street in Austin. Charles D. Kinney was 78, had been born in Texas, and had no occupation listed. He had lived in Childress, Texas in 1935.

Her 1936 death certificate shows that Norma Mable Kinney was living in this house at the time of her death. She was born in Missouri in 1870, and is listed as a housewife.

His 1942 death certificate shows that Dr. Charles Dexter Kinney was living at 2900 Lafayette Street in Austin at the time of his death. He was widowed. He had been born in Austin in 1860 and was a chiropractor.

## William Roy and Maxine Ray (ca. 1940 – ca. 1948)

His World War I draft registration card shows that William Roy Ray was born in 1898. He was living in his mother's house at 90 San Jacinto Street in Austin, and was a book-keeper. He was of medium height and build, and had grey eyes and light hair.

William R. and Maxine Ray appear as the owners of the house at 1201 W. 34<sup>th</sup> Street in Austin in the 1940 U.S. Census. William R. Ray was 42, had been born in Texas, and was a bookkeeper for a retail auto parts store. Maxine Ray was also 42, and had been born in Texas. She had no occupation listed. They had 2 children: Roy M., 17; and Leitress Ann, 12. Both children had been born in Texas. The family had lived in Corpus Christi, Texas in 1935.

His 1979 death certificate shows that William Roy Ray had been living in Baird, Texas for the 11 years prior to his death. He was born in 1898 in Runge, Texas, and was an accountant in public finance.

### Lewis and Addie LaBorde (ca. 1950 - ca. 1980)

The 1930 U.S. Census shows Lewis LaBorde was the 28-year old nephew of Jules Fontenelle, who owned his own home in Mansura, Louisiana. Lewis LaBorde had been born in Louisiana and was a painter of frame buildings. His uncle, Jules, was a 57-year old Louisiana-born widower who owned a blacksmith shop.

The 1910 U.S. Census shows Lewis LaBorede as the 3-year old son of Valerien and Melanie LaBorde of Police Jury Ward 8 in Avoyelles Parish, Louisiana. Lewis' father was a Louisianaborn farmer. They owned their farm.
