Councilman Lebermann took this opportunity to announce that for a variety of reasons he had decided not to bring up his proposal.

Councilman Binder moved that the aide program be reinstated as before with an additional proviso that previous to the hiring there will be an affirmative vote of four Councilmen, and he introduced the following ordinance:

Council Discussion

In response to Mayor Butler's question, Mr. Joe Liro, Management and Budget Administrator, noted that the reinstatement of the aides would entail an annual expense of \$66,000.

Councilman Dryden did not see how the Council could be saving the taxpayers any money by spending \$66,000.

Mayor Butler mentioned that the Council had eliminated the aide program as a budgetary matter and had lowered expenses to the citizens. He, therefore, felt that the Council was going in the wrong direction.

Councilman Lebermann stated that one of the reasons he had pulled down his proposal was because of budgetary concerns for this year and continuing into the following year. He appealed to his colleagues on the Council to put this motion aside.

The following appeared in opposition to the Motion before Council:

MR. DICK HODGKINS stated that he was tired of the Council playing politics with the citizens' pocketbooks. He felt that it was unconscionable for the Council to be considering a dual plan. He suggested that the citizens would remember the Council's actions today.

MR. JAY JOHNSON felt that the Council had cut some services to the public and was now going to come back and spend in excess of what was cut. He also felt that having an aide did not make a Councilman more available to the public in that the aides were isolating the Councilmen and insulating them from the public.

Vote on Motion

Roll call on Councilman Binder's motion, Councilman Handcox's second, to reinstate the aide program showed the following vote:

Hodgkins and Johnson did not represent all the citizens of Austin, but he felt that they represented the feelings of a great number of them as well as himself. He felt that the Council was not helping the citizens in this matter, and he did not understand the Councilmen's thinking.

AMENDMENT TO OPERATING BUDGET - COMPENSATION AND/OR EXPENSES

It was noted that the Council had before it the third reading of an ordinance amending the 1974-1975 Operating Budget by authorizing compensation and/or expenses of the office of the City Council.

The motion was seconded by Councilman Handcox.

Substitute Motion

Mayor Pro Tem Love moved that the ordinance be amended so that the Council would be compensated in the amount of \$95 per week, retroactive to October 1, 1974, and to be paid in advance each month, and the amended ordinance be finally passed as follows:

AN ORDINANCE AMENDING ORDINANCE NO. 740919-B TO APPROPRIATE FROM UNAPPROPRIATED GENERAL FUNDS AND TRANSFER TO THE CITY COUNCIL'S OFFICE THE AMOUNT OF \$30,940.00; AUTHORIZING AN INCREASE IN CITY COUNCILMEN'S EXPENSE ALLOWANCE; PROVIDING FOR NECESSARY TRANSFERS AND ADJUSTMENTS; AND DECLARING THIS ORDINANCE TO BE SEVERABLE.

Councilman Binder seconded the substitute motion.

Council Discussion

Mayor Pro Tem Love stated that he had worked with each Councilman in the area of pay and aides and felt that Councilman Binder's motion for \$12,000

annually was very fair and that his substitute motion of \$95 per week was more than a compromise. He indicated that at the end of the year if the money had not been spent, taxes must be paid on it.

Councilman Dryden noted that he was confused in that it had been his recollection that Mayor Pro Tem Love had made the motion to eliminate the aide program during the budget hearing.

Councilman Lebermann requested that the Councilmen think this through carefully and send it back to the people for their judgement as to whether or not the Council should be paid.

Mayor Butler quoted various figures as being Councilmen's pay in various cities in Texas and noted that the \$95 per week figure represented a 850% increase in Austin City Councilmen's pay. He felt that the Council was making a great mistake and hoped that since the aide program had been reinstated through its first reading, the Council would turn down this pay increase.

The following appeared in opposition to the pay proposal:

MR. JACK McCREARY stated that he was in support of the aides and felt that the Council had made an error in judgement by abolishing the aide program; however, he felt that the pay proposal was a disgrace and against the integrity of the voters. He suggested that this issue be placed before the voters in April.

Vote on Substitute Motion

Roll call on Mayor Pro Tem Love's substitute motion, Councilman Binder's second, showed the following vote:

ORDINANCE PROHIBITING BEGGING IN PUBLIC PLACES

It was noted that the Council had before it the third reading of an ordinance prohibiting begging in public places. MR. CECIL HENNIGER suggested that people should love their neighbor, and he felt that this ordinance did nothing but hurt the people who found it necessary to beg for money. He quoted various scriptures from the <u>Bible</u> and suggested that this would put more burdens on the poor people than anything the Council had done.

MR. FRED YOUNG stated that he had seen a different situation than what Mr. Henniger had spoken of and added that there was a problem on the Drag with the panhandlers.

MR. PETER W. DAVIS, reporter for the Rag Newspaper, stated that he went up and down the Drag 4 or 5 times a day and had never been harassed or threatened.

Mayor Butler brought up the following ordinance for its third reading:

AN ORDINANCE AMENDING CHAPTER 23 OF THE AUSTIN CITY CODE OF 1967, BY ADDING THERETO A NEW SECTION DESIGNATED SECTION 23-50, PROHIBITING BEGGING IN PUBLIC PLACES; AND DECLARING AN EMERGENCY.

The ordinance was read the third time, and Mayor Pro Tem Love moved that the ordinance be finally passed. The motion, seconded by Councilman Dryden, carried by the following vote:

CITY MANAGER REPORTS

It was noted that the Council had before it for possible acceptance two reports concerning Transit Service Revisions and the Park and Ride Program. City Manager Davidson stated that both reports were intended to update the Council; and in connection with Transit Service Revisions, he wanted to know the Council's feeling as to whether or not the City was headed in the right direction as far as curtailing some of the non-essential transit services to accommodate budget action. Mayor Butler indicated that it was his understanding that Mr. Joe Ternus, Urban Transportation Director, had been given the latitude concerning where the City could cut most effectively and effect the fewest number of people.

Mr. Ternus pointed out that the staff would come back at a later date for the formal adoption of these reports. Therefore, it was the consensus of the Council that the afore-mentioned reports be received.

PRESENTATION OF BICENTENNIAL PLAN

Ms. Maline McCalla, Co-Chairperson of the Austin Bicentennial Commission, appeared before the Council to give a slide presentation of the Austin Bicentennial Plan. She indicated that one reason for the presentation was to show the Council what the Commission had done with citizen cooperation in the last 12 months. Upon completion of the presentation, she invited everyone to attend the presentation of the Bicentennial flag at the Old Bakery, Bicentennial Headquarters, on Monday, November 11, 1974.

Mayor Butler announced that the Council would go into Executive Session in the Electric Building Conference Room as authorized by Section 2, Paragraphs (e) and (f) of Article 6252-17, Texas Revised Civil Statutes.

The Council recessed at 4:40 p.m. to go into Executive Session.

EXECUTIVE SESSION ACTION

Mayor Butler called the meeting to order at 4:55 p.m. Councilman Dryden moved that the Council authorize the City Attorney to negotiate settlement on the matter which has been pending on the improvement of Shoal Creek since about 1969, allowing the City to enter into certain agreements with the owners of the property to resolve the matter and authorize the City Manager to execute such instruments as may be necessary to effect the agreement (between 34th and 38th Streets).
