**1. CALL TO ORDER**

- a. Mueller Residential Speed Limits: After citizen communication on this item, Laura Dierenfield and Amica Bose with the Austin Transportation Department provided information related to the City's Vision Zero Program, Council direction to staff for further study on speed limits, and potential City pilot program to reduce speed limits in selected residential areas.

Commissioners discussed and approved, with edits, a resolution to Council to encourage and support high frequency and rapid transit options on primary corridors in and near Mueller, on Commissioner Byars' motion and Commissioner Bowman's second on a 10-0 vote.

- a. Mueller Density Working Group Update: Commissioner Byars provided a brief update on the PIAC Mueller Density Working Group work to date, including meetings, document research and review, and potential next steps for future meetings.
