The Community Development Commission (CDC) convened in a regular meeting on Tuesday, December 13, 2016, at the Street-Jones Building, 1000 E. 11th Street, Austin, TX, Room 400A.

2. APPROVAL OF MINUTES

The motion to approve the October 11, 2016, meeting minutes was made by Commissioner McGhee, seconded by Commissioner Taylor, and approved unanimously.

3. UPDATE FROM THE CDC HOUSING COMMITTEE

Briefing from the CDC Housing Committee, discussion, and possible action (Karen Paup, CDC Commissioner)

Commissioner Paup briefed the CDC.

4. COMMUNITY SERVICES BLOCK GRANT (CSBG)

- a. Briefing and discussion on the Community Services Block Grant (Maria Allen, Manager, Neighborhood Services Unit, Health and Human Services Department)

Maria Allen, HHSD, presented.

- b. Briefing, discussion, and possible action regarding revision of the CDC bylaws related to changes in City Code Section 2-1-127 (Maria Allen, Manager, Neighborhood Services Unit, Health and Human Services Department)

Maria Allen, HHSD, briefed the board. Commissioner McHorse moved to approve the proposed revisions to the CDC bylaws and changes in City Code Section 2-1-127, stated in Ordinance 20161020-012, and Commissioner [inaudible] seconded the motion. The motion failed on a 5-5-1 vote. Those voting aye were: Commissioners McHorse, Paup, Hinely, Fadelu and Rocio Villalobos. Those voting nay were: Commissioners Tolliver, McGhee, Taylor, Dailey and Ana Villalobos. Commissioner Deshotel abstained. Commissioners Rivera, Zamora and Singer were absent.

- c. Briefing, discussion, and possible action regarding additional recommendations related to CSBG and TDHCA's monitoring report (Maria Allen, Manager, Neighborhood Services Unit, Health and Human Services Department)

Maria Allen briefed the commission and suggested the formation of a working group to collaborate with HHSD staff in addressing issues related to the CSBG bylaws and TDHCA reporting process. Commissioners McGhee, Dailey and Ana Villalobos volunteered to serve on the proposed CSBG Bylaws and TDHCA Report Working Group. Commissioner Dailey moved that Commissioner McGhee chair the working group and the motion was seconded by Commissioner McGhee. Vice Chair Deshotel moved that the board approve the formation of the CSBG Bylaws and TDHCA Report Working Group, with Commissioner McGhee as the working group's Chair. The motion was approved unanimously.
